LIMITS OF THE MUNICIPAL CORPORATION OF FAMAGUSTA.

In exercise of the powers vested in him by section 6 of the Municipal Corporations Laws, 1930 to 1938, His Excellency the Governor has been pleased to declare and hereby declares that as from the date of the publication of this notice in the Gazette the limits of the Municipal Corporation of Famagusta shall be as set forth in the Schedule hereto.

2. All previous notifications relating to the limits of the Municipal

Corporation of Famagusta shall be cancelled.

SCHEDULE.

Limits of the Municipal Corporation of Famagusta.

The boundary commences at the most northern point of plot No. 111, Block D, Ay. Loukas Quarter, (Government Survey Plan No. XXIV/51.E), on the seashore, locality "Karaolos," and proceeds south-eastwards along the seashore (but including all islands off the seashore) to the mouth of the stream which is the southern boundary of plot No. 192, Block F, Ay. Memnon Quarter (Government Survey Plan No. XXXIII. 30.4.III), locality "Limnara"; thence south-westwards up this stream to the most eastern point of plot No. 197, Block F, Ay. Memnon Quarter, (Government Survey Plan No. XXXIII.30.4.III), locality "Dhromos tou Xenti"; thence south-westwards and north-westwards along a road to the junction of roads at the most eastern corner of plot No. 199, Block F, Ay. Memnon Quarter (Government Survey Plan No. XXXIII.29.6.IV), locality "Exintara"; thence south-westwards along a road to the most southern point of plot No. 209, Block F, Ay. Memnon Quarter, (Government Survey Plan No. XXXIII.37.3.I), locality "Beylitika," on the aqueduct; thence north-westwards along the aqueduct to the road at the southern boundary of plot No. 60, Block D, Ay. Memnon Quarter, (Government Survey Plan No. XXXIII.29.2.III), on which stands Ay. Memnon Church; thence south-westwards along the said road to its junction with the main road from the village of Dherinia to Varosha at the most southern point of plot No. 41, Block A, Ay. Memnon Quarter, (Government Survey Plan No. XXXIII.29.4.I), locality "Tekkelitika"; thence north-westwards along the said main road to the most southern point of plot No. 42, Block E, Kato Varosha Quarter (Government Survey Plan No. XXXIII.29.W); thence north-westwards along another road (to the village of Phrenaros) to the junction of roads at the south-western corner of plot No. 23, Block E, Kato Varosha Quarter, (Government Survey Plan No. XXXIII.28.W), locality "Dhyo Loutsia"; thence northwards along another road (to Varosha) to the most eastern point of plot No. 179, Block D, Kato Varosha Quarter, (Government

Survey Plan No. XXXIII.28.W); thence north-westwards along the boundaries of, and including, plots Nos. 179, 180, 232 and 238 of the said block to the most western point of plot No. 238, on the stream "Pharangas"; thence south-westwards up this stream to the most southern point of plot No. 195 of the said block, locality "Kremni"; thence north-westwards along the boundaries of, and including, plots Nos. 195, 196 (Government Survey Plan No. XXXIII.28.W), 243, 127 (Government Survey Plan No. XXXIII.27.E), locality "Ayios Yeoryios-tou-Pharangou," 212, 207 and 44, Block D, Kato Varosha Quarter (Government Survey Plan No. XXXIII.19.E), to the most western point of plot No. 44, locality "Kaminin tou Kiayia," on a road; thence south-westwards along the said road to the most western point of plot No. 1, Block D, Kato Varosha Quarter (Government Survey Plan No. XXXIII.19.W), on the main road from Famagusta to Larnaca; thence south-westwards along the said main road to the most southern point of plot No. 279, Block B, Ay. Loukas Quarter (Government Survey Plan No. XXXIII. 19.W), locality "Strovilia"; thence north-westwards along another road (to the village of Kalopsidha) to the most eastern point of plot No. 381, Block B, Ay. Loukas Quarter (Government Survey Plan No. XXXIII.18.E), locality "Verou"; thence south-westwards and northwards along the boundaries of, and including, plots Nos. 381, 250, 366, 103 (Government Survey Plan No. XXXIII.18.E), 102, 101, 100, 99, 364, 98, 90, 89, 88, 4, 3, 2 and 1, Block B, Ay. Loukas Quarter (Government Survey Plan No. XXXIII.10.E), to the most western point of plot No. 1 on a road adjoining the stream "Ayios Mamas"; thence north-westwards along the said stream to the north-western corner of plot No. 7, Block E, Ayios Loukas Quarter (Government Survey Plan No. XXIV.58.W); thence north-eastwards along the boundaries of, and including, plots Nos. 7, 3, 1 and 2, locality "Mouti-tis-Khalis," plots Nos. 6 and 15 (Government Survey Plan No. XXIV.58.W), plots Nos. 134, 17, 21, 24, 22, 23, 24, 25 and 67, (crossing the Cyprus Government Railway), 27, 28, 29, 30, 31 (Government Survey Plan No. XXIV.58.E), plots Nos. 32, 33, 34 and 35, Block E, Ayios Loukas Quarter, (Government Survey Plan No. XXIV.59.W), to the north-eastern corner of plot No. 35, on a water-channel; thence north-westwards along the said channel to the north-western corner of plot No. 12, Block D, Ayios Loukas Quarter (Government Survey Plan No. XXIV.59.W); thence north-eastwards along the boundaries of, and including, plots Nos. 12, 13, 14, 15, 11, 10 and 35, Block D, Ay. Loukas Quarter (Government Survey Plan No. XXIV. 59.W), to the most western point of Ayios Yeoryios Church; thence north-westwards in a straight line, (crossing the Famagusta-Karpas main road) to the point at which the water channel running north-westwards through the plot No. 113, Block D, Ayios Loukas Quarter, meets the north-western boundary of this plot (Government Survey Plan No. XXIV. 51.W); thence north-eastwards in a straight line along the said waterchannel to the seashore (Government Survey Plan No. XXIV.51.E); thence north-eastwards along the seashore to the point of commencement.
