ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940, I hereby order as follows :-

1. This Order may be cited as the Defence (Certain Motor Spirit) Order, 1940, and shall be read in conjunction with the Defence (Return of Stocks of Motor Spirit) Order, 1940, (hereinafter referred to as "the Order").

2. No person who has completed and delivered under the Order a return of the motor spirit in his possession or under his control shall sell, remove, consume or otherwise dispose of, any motor spirit in respect of which the return was made save under a permit in writing issued by me in that behalf:

Provided that any person who is also a registered retailer may without such permit sell or otherwise dispose in accordance with the provisions of the Defence (Motor Spirit) (Rationing) Order, 1940, a quantity of motor spirit not exceeding 50 gallons.

3. Any person who acts in contravention of the provisions of this Order is liable to the penalties prescribed in Regulation 94 of the Defence Regulations, 1940.

## THE DEFENCE REGULATIONS, 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940, I hereby order as follows :-

1. This Order may be cited as the Defence (Certain Imported Olive Oil) (Exemption) Order, 1940, and shall be read in conjunction with the Orders set out in the Schedule hereto (in this Order referred to as " the Orders").

2. From and after the date of the publication of this Order in the Gazette imported olive oil in new sealed tins or bottles of less than 5 kilos in weight, each of which is marked with a brand name, shall be exempted from the operation of the Orders.
