THE GAME AND WILD BIRDS LAWS, 1934 AND 1938.

ORDER IN COUNCIL No. 1966

MADE UNDER SECTION 15.

W. D. BATTERSHILL, Governor.

- I, the Governor in Council, in exercise of the powers conferred by section 15 of the Game and Wild Birds Laws, 1934 and 1938, do hereby order as follows:—
- 1. This Order may be cited as the Temporary Game Reserve Areas Order, 1940.
- 2. The areas specified in the Schedule hereto shall be and are hereby declared to be Temporary Game Reserve areas for the period between the 11th day of September, 1940, and the 10th day of September, 1941, both days inclusive.

SCHEDULE.

Area No. 1 (Kyrenia District):

The boundary commences at the village of Myrtou and goes northwards and eastwards along the Myrtou-Kyrenia main road to the town of Kyrenia; thence south-eastwards and south-westwards following the Kyrenia-Nicosia main road to the turning to the village of Aghirda; thence south-westwards, along this road through the latter village to the village of Photta; thence north-westwards, along a road to the road from the village of Krini to the village or Ayios Ermolaos; thence south-westwards along the latter road through the village of Ayios Ermolaos to the village of Kondemenos; thence north-westwards along the main road from Nicosia to Myrtou to the point of commencement.

Area No. 2 (Nicosia District):

The boundary commences at mile post No. 25 on the main road from Troödos to Nicosia and goes north-eastwards along the latter road to the turning to the village of Vizakia, about two miles south-west of the village of Astromeritis; thence southwards and south-westwards along the road through the villages of Vizakia, Kannavia, Ayia Irini, Kourdhali and Spilia to the main road from Troödos to Nicosia near mile post No. 40; thence north-westwards and north-eastwards along the latter road to the point of commencement.

Area No. 3 (partly in Nicosia District and partly in Larnaca District):

The boundary commences at the point at which the road to the village of Analiondas leaves the road from the village of Pera to the village of Kapedhes and goes eastwards along the former road to the village of Analiondas; thence southwards along the road to the village of Lythrodhonda; thence south-eastwards, along a footpath to the main road from the village of Kornos to Pano Lefkara; thence south-westwards, along the latter road to Pano Lefkara; thence north-westwards along the road to the village of Vavatsinia; thence north-westwards in a straight line to the summit of the mountain "Kionia"; thence northwards in a straight line to the Makheras Monastery; thence

north-eastwards, along the road to the village of Kapedhes; thence northwards along the road leading to the village of Pera to the point of commencement.

Area No. 4 (partly in Limassol District and partly in Larnaca District):

The boundary commences at the point at which the road to the villages of Monagroulli and Asgata leaves the main road from Nicosia to Limassol, and proceeds north-eastwards along the said village road through the village of Monagroulli to the village of Asgata; thence south-eastwards along the road to Zyyi to the village of Kalavasos; thence easterly following the footpath across the "Vasilikos" river to the village of Tokhni; thence north-eastwards along the loop road passing through Tokhni to its junction with the Limassol-Nicosia main road; thence north-easterly along the Limassol-Nicosia main road to the river "Pendaskinos"; thence south-eastwards down this river to the seashore; thence south-westwards along the seashore to the Limassol-Larnaca District boundary; thence northwards along this boundary to the Limasol-Nicosia main road; thence westerly along this road to the point of commencement.

Area No. 5 (partly in Nicosia District and partly in Larnaca District):

The boundary commences at the point where the road from Margo to Tymbou joins the Nicosia–Larnaca main road; thence north-easterly along the former road to the village of Tymbou; thence southerly along the road from the village of Tymbou to the village of Athienou; thence southerly following the road through the villages of Athienou, Avdhellero and Aradhippou to the junction of this road with the Nicosia–Larnaca main road; thence north-westerly and northerly along the Nicosia–Larnaca main road to the point of commencement.

Area No. 6 (partly in Limassol District and partly in Paphos District):

The boundary commences at the bridge on the Limassol-Paphos main road over the river "Kha-Potami", and proceeds north-eastwards along the left bank of the said river to the point at which it is crossed by the footpath from the village of Mousere to the village of Anoyira at the locality "Vrysi tis Elinias"; thence south-eastwards along the said footpath to Anoyira; thence south-eastwards along the road through the village of Evdhimou to the main Limassol-Paphos road; thence westwards and north-westwards along the said main road to the point of commencement.

Area No. 7 (partly in Kyrenia District and partly in Famagusta District):

The boundary commences at the village of Knodhara, on the main road from Lefkoniko to Nicosia, and proceeds north-westwards along the road to the village of Trypimeni; thence north-westwards to Ayios Amvrosios carob-stores along the road from Trypimeni to Ayios Amvrosios carob-stores; thence eastwards along the seashore to the jetty of Akanthou; thence south-eastwards and south-westwards along the road from Akanthou jetty to Ayios Amvrosios to the junction of the road to Lefkoniko; thence southerly along this road to Lefkoniko; thence westerly along the Lefkoniko-Nicosia road to the point of commencement.

Area No. 8 (Famagusta District):

The boundary commences at the Kantara Summer Resort and proceeds north-eastwards along the road to Koronia and thence to Kantara Castle; thence north-eastwards along a footpath through the locality "Ayios Photios" to the locality "Kornos" on the road from the village of Dhavlos to the village of Komi Kebir; thence southeastwards along the said road to the village of Komi Kebir; thence southwards to the Karpas main road along the road through the village of Patriki; thence south-westwards along the said main road to Boghaz Plantation; thence north-eastwards along the road to the village of Yerani through the village of Ayios Elias; thence north-westwards along a footpath to the point of commencement.

2. The proviso to clause 3 of the principal Order is hereby amended by the insertion therein, immediately after the word "apply" (line 1) of the following:

to the reception of News Bulletins from any station other than a station operating in or transmitting such news from an enemy or an enemy occupied territory or ".
