The boundary commences at the Kantara Summer Resort and proceeds north-eastwards along the road to Koronia and thence to Kantara Castle; thence north-eastwards along a footpath through the locality "Ayios Photios" to the locality "Kornos" on the road from the village of Dhavlos to the village of Komi Kebir; thence south-eastwards along the said road to the village of Komi Kebir; thence southwards to the Karpas main road along the road through the village of Patriki; thence south-westwards along the said main road to Boghaz Plantation; thence north-eastwards along the road to the village of Yerani through the village of Ayios Elias; thence north-westwards along a footpath to the point of commencement.

No. 343.**THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1940.****ORDER MADE UNDER REGULATION 75.**

I, the Governor, in exercise of the powers conferred by Regulation 75 of the Defence Regulations, 1940 to (No. 1) 1940, do hereby make the following Order:—

1. This Order may be cited as the Defence (Loud Speakers Restriction) Amendment Order, 1940, and shall be read as one with the Defence (Loud Speakers Restriction) Order, 1940, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Loud Speakers Restriction) Orders, 1940.

2. The proviso to clause 3 of the principal Order is hereby amended by the insertion therein, immediately after the word "apply" (line 1) of the following:—

"to the reception of News Bulletins from any station other than a station operating in or transmitting such news from an enemy or an enemy occupied territory or".

Whereas His Excellency the Governor has, under section 52 of the Elementary Education Laws, 1933 to (No. 2) 1937, by Order published under Notification No. 64 in Supplement No. 3 to the *Gazette* dated the 21st day of February, 1940, ordered the Committee of Management for Maronite Schools to erect school latrines in the village of Asomatos, in the District of Kyrenia:

And whereas the necessary estimates and plans have been prepared under section 53 of the above-mentioned Laws :

And whereas a loan amounting to the sum mentioned in the third column of the Schedule hereto has, under section 51 (1) of the said Laws, been raised to meet the expense of providing such buildings as aforesaid :

Now, therefore, in pursuance of the powers vested in him by section 71 of the Elementary Education Laws, 1933 to (No. 2) 1937, His Excellency the Governor has been pleased to order and it is hereby ordered that in order to provide for the annual interest and sinking fund in respect of the loan aforesaid the sum of money mentioned in the fourth column of the said Schedule be recovered from the Maronite taxpayers of the village mentioned in the second column of the said Schedule in manner provided by section 74 of the said Laws.

ORDER BY THE GOVERNOR UNDER SECTION 71.

Whereas His Excellency the Governor has, under section 52 of the Elementary Education Laws, 1933 to (No. 2) 1937, ordered the Town Committees and Village Commissions for Orthodox-Christian Schools mentioned in the second column of the Schedule hereto to provide school buildings, premises, playgrounds, yards, gardens or teachers' dwellings :

And whereas the necessary estimates and plans have been prepared under section 53 of the above-mentioned Laws :

And whereas loans amounting to the sums mentioned in the third column of the Schedule hereto have, under section 51 (1) and (2), been raised to meet the expense of providing such buildings as aforesaid :

Now, therefore, in pursuance of the powers vested in him by section 71 of the Elementary Education Laws, 1933 to (No. 2) 1937, His Excellency the Governor has been pleased to order and it is hereby ordered that in order to provide for the annual interest and sinking fund in respect of the loans aforesaid the sums of money mentioned in the fourth column of the said Schedule hereto be recovered respectively from the church or churches, monastery or throne and the Orthodox-Christian inhabitants of the towns and villages mentioned in the second column of the said Schedule in manner provided by section 72 of the above Laws.
