## THE PETROLEUM LAW, 1939.

## REGULATIONS MADE UNDER SECTION 9.

I, the Governor in Council, in exercise of the powers conferred by section 9 of the Petroleum Law, 1939, do hereby make the following Regulations:—

1. These Regulations may be cited as the Petroleum (Amendment No. 1) Regulations, 1940, and shall be read as one with the Petroleum Regulations, 1940, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Petroleum Regulations, 1940 to (No. 1) 1940.

2. Regulation 37 of the principal Regulations is hereby amended by the insertion immediately after the word "container" (line 1) of the words "or in drums fitted with an efficient screwed stopper".

3. Regulation 56 of the principal Regulations is hereby repealed and the following Regulation substituted therefor:—

"56. The Licensing Authority may, upon application of any person:—

(a) grant to such person a licence for a roadside pump drawing Petroleum Class A from an underground storage tank, upon the production of a certificate of the Director that the premises in respect of which the application is made and the proposed type of tank and roadside pump is suitable and safe for the purpose;

(b) grant to such person a licence for a portable pump for the purpose of charging the tanks of motor vehicles from drums or other receptacles approved by the Director subject to such terms and conditions as the Licensing Authority may deem fit to impose."

4. Regulation 58 of the principal Regulations is hereby amended by the deletion therefrom of the words "The tank and pump" and the substitution therefor of the words "The underground storage tank and roadside pump".

5. Regulation 67 of the principal Regulations is hereby amended by the insertion immediately after the words "motor vehicles" (line 1) of the words "by a roadside pump drawing from an underground tank".
