THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me in virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940 to (No. 2) 1940, I hereby order as follows :---

1. This Order may be cited as the Defence (Returns of Stocks and Restriction of Sale of Newsprint) Amendment Order, 1940, and shall *Gazette*: be read as one with the Defence (Returns of Stocks and Restriction Supplement of Sale of Newsprint) Order, 1940, (hereinafter referred to as "the No. 3: principal Order "), and the principal Order and this Order may together be cited as the Defence (Returns of Stocks and Restriction of Sale of Newsprint) Orders, 1940.

2. Clause 2 of the principal Order is hereby amended by the deletion from the definition "Dealer in newsprint" of the words "for the purposes of sale whether by retail or by wholesale".

3. Clause 3 of the principal Order is hereby amended by the deletion therefrom of the words "Within 5 days of the date of the publication of this Order in the *Gazette*, every dealer in newsprint and every newspaper proprietor shall" (*lines* 1 and 2) and the substitution therefor of the following words:—

"Every dealer in newsprint and every newspaper proprietor shall, on or before the tenth day of October, 1940,".
