THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF NICOSIA.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1938, or otherwise, the Council of the Municipal Corporation of Nicosia hereby make the following Bye-laws :—

1. These Bye-laws may be cited as the Nicosia Municipal (Amendment) Bye-laws, 1940, and shall be read as one with the Nicosia Municipal Bye-laws, 1938 to 1939, (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these Bye-laws may together be cited as the Nicosia Municipal Bye-laws, 1938 to 1940.

2. Bye-law 151 of the principal Bye-laws is hereby amended as follows :—
(a) Sub-paragraphs (a) and (b) of paragraph (2) are hereby repealed.
(b) By the insertion of the following paragraph immediately after paragraph (2) :—

"(2A) There is hereby provided for the storage of petroleum Class A, B and C the following place :—

The premises situated outside the village of Kaimakli on the right of the road leading to the village of Kythrea, and bounded by water channel, Katinou Kyriacou pl. 541, Savvas Kyriacou pl. 542, Road, Yiannakos Korajitis pl. 544, Yeorghios Haji Hari Maghos pl. 545 and Papa Yeorghiou Atshos pl. 546."

3. These Bye-laws shall be deemed to have come into operation on the 18th day of June, 1940.

The above Bye-laws have been approved by His Excellency the Governor. (M.P. 24/40.)
