THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE GOVERNOR UNDER REGULATION 70.

I, the Governor, in exercise of the powers conferred by Regulation 70 of the Defence Regulations, 1940 to (No. 3) 1940, do hereby order as follows:—

1. This Order may be cited as the Prohibited Areas Order (No. 3) 1940, and shall be read as one with the Prohibited Areas Orders, 1940, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Prohibited Areas Orders, 1940 to (No. 3) 1940.

2. The Schedule to the principal Order is hereby amended by the insertion after Area No. 1 under the heading of "Famagusta Town and Harbour Prohibited Area", of a new area, Area No. 1A, as per Schedule hereto.

SCHEDULE.

Commencing at a point on the north boundary of the road junction lying S.E. of the Jambulat Bastion and where the Railway Line crosses the road, the boundary of the area follows the Railway Line north-easterly to the railway spur to the Shell Company's Yard; thence north-east a distance of about 20 feet to the apron wall of the harbour; thence north-westwards along the apron wall to Low Water Mark; thence following the Low Water Mark easterly and north-easterly to the northerly extremity of the chain of rocks between the islands Nisi Megalon and Nisi ton Maymounion; thence south-easterly along the easterly limit of these rocks to the island Nisi Megalon; thence following the shores of this island northerly, easterly and southerly to the causeway connecting it to the island Nisi tou Jieri; thence round the easterly and southerly shores of this island and including it within the area to the causeway connecting it to the mainland; thence along the southerly boundary of the causeway to where it joins the road to the Customs Department Offices; thence following the northern boundary of this road, westerly a distance of 150 feet approximately to a point immediately opposite the north-westerly corner of plot 326, Block C, Varosha Quarter, Famagusta; thence southerly, westerly and northerly along the boundaries of, and including the area, plots 14, 240, 329, 328, 330, 45, 239, 51, 238, 240, 229, 228, 243, of Block C, Varosha Quarter, Famagusta, to the north-western corner of the said plot 243; thence northerly to a point on the south side of the road leading from the Customs Department Offices to Nisi tou Jieri about 130 feet east of the house occupied by the Harbour Master; thence northerly crossing this road and thence westerly along the north boundary of this road to the point of commencement.
