

No. 413. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.**DELEGATION OF POWER UNDER PARAGRAPH (5) OF REGULATION 66.**

In exercise of the powers vested in him by paragraph (5) of Regulation 66 of the Defence Regulations, 1940 to (No. 3) 1940, His Excellency the Governor has been pleased to depute and hereby deputes the person for the time being holding the office designated in the second column of the Schedule hereto to exercise and perform on the Governor's behalf the powers mentioned in the first column of the said Schedule which the Governor is empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of Regulation 66 of the Defence Regulations, 1940 to (No. 3) 1940.

SCHEDULE.

<p>The power to requisition— (a) water carts together with the animals ordinarily used for drawing same and any appliances or things used in connection therewith; (b) any vehicle ordinarily used for the purpose of carrying water and any appliances or things used in connection therewith; and the powers connected with such requisitioning conferred by paragraphs (1), (2), (3) and (4) of Regulation 66 of the Defence Regulations, 1940 to (No. 3) 1940.</p>	<p>Commissioner of each District.</p>

No. 414. THE ELEMENTARY EDUCATION LAWS, 1933 TO (No. 2) 1937.**REGULATIONS MADE UNDER SECTION 5.**

I, the Governor, in exercise of the powers conferred by section 5 of the Elementary Education Laws, 1933 to (No. 2) 1937, do hereby make the following Regulations:—

1. These Regulations may be cited as the Elementary Education (Holidays) (Amendment) Regulations, 1940, and shall be read as one with the Elementary Education (Holidays) Regulations, 1936, (hereinafter called "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Elementary Education (Holidays) Regulations, 1936 and 1940.

2. Paragraphs (b) and (c) of Regulation 3 of the principal Regulations are hereby amended by the insertion in each case at the end thereof of the following:—

"Provided that this paragraph shall not apply to any Orthodox-Christian elementary school prescribed for the village of Pano Amiandos".

3. Paragraph (e) of Regulation 3 of the principal Regulations is hereby amended by the insertion therein,

(a) after the words "the Presentation of the B.V.M. (21st November);",
of the words "St. Andrew (30th November);"; and

(b) after the words "St. Constantine and St. Helena (21st May);", of the words "Ascension Day;".

4. Paragraph (b) of Regulation 4 of the principal Regulations is hereby amended by the insertion at the end thereof of the following:—

"Provided that this paragraph shall not apply to any Moslem elementary school prescribed for the village of Pano Amiandos".

5. The principal Regulations are hereby amended by the insertion therein after Regulation 6 of the following Regulation:—

"6A. The following holidays shall be observed in any Orthodox-Christian or Moslem elementary school prescribed for the village of Pano Amiandos in addition to the holidays to be observed, under these Regulations, in such schools respectively:—

(a) From the 16th August till the 31st August, inclusive;

(b) From the 22nd December till the 14th March, inclusive."

6. Regulation 7 of the principal Regulations is hereby amended by the deletion therefrom of the words beginning with "in the afternoon" (line 5) to the end of the Regulation.
