No. 416. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940 to (No. 3) 1940, I hereby order as follows :—

1. This Order may be cited as the Defence (Conservation of Olive Stones) Amendment Order, 1940, and shall be read as one with the Defence (Conservation of Olive Stones) Order, 1939, (hereinafter called "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Conservation of Olive Stones) Orders, 1939 and 1940.

2. Clause 2 of the principal Order is hereby amended by the addition thereto of the following proviso :—

" Provided that uncrushed olive stones may be used as fuel under a special licence given under my hand, or under the hand of the Commissioner of the District, and subject to such terms and conditions as may be specified in such licence."
