## THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940 to (No. 3) 1940, I hereby order as follows:-

1. This Order may be cited as the Defence (Registration of Bakers) (Amendment) Gazettes: (No. 2) Order, 1940, and shall be read as one with the Defence (Registration of Bakers) Orders, 1940, (hereinafter called "the principal Order") and the principal Order and this Order may together be cited as the Defence (Registration of Bakers)

Orders to (No. 2) 1940.

2. Clause 2 of the principal Order is hereby amended by the addition thereto

of the following definition:—

"Barley flour" and "whole wheat flour" have the same meaning as in the Defence (Sale of Barley flour and Wheat flour) Order, 1940.

3. Clause 5 of the principal Order is hereby amended by the deletion therefrom of sub-paragraph (b) and the substitution therefor of the following sub-paragraph:-

"(b) shall sell or offer for sale or expose for sale any bread, except bread prepared, made or baked from imported flour or whole wheat flour or both, or from an admixture in the proportions specified in Clause 6 of the Order."

4. Clause 6 of the principal Order is hereby revoked and the following clause substituted therefor:

"6. The admixture referred to in Clause 5 of the Order shall contain at least 85% of imported flour or whole wheat flour, or both, and not more than 15% of barley flour or of cooked potatoes or of flour made from dried beans (koukkia), or of any combination thereof."

5. Clause 8 of the principal Order is hereby revoked and the following clause

substituted therefor:

"8. Every registered baker shall keep in his bakery a book in which he shall enter, or cause to be entered, daily, particulars in respect of the number of loaves of bread prepared or made or baked in his bakery and the quantities of the ingredients used in the preparation of such loaves.

## IRRIGATION DIVISION OF MENIKO. Rules.

1. These Rules may be cited as the Irrigation Division of Meniko (Amendment) Rules, 1940, and shall be read as one with the Irrigation Division of Meniko Rules, 1932 and 1937, (hereinafter called "the principal Rules"), and the principal Rules

No. 3: 11.6.1940 and these Rules may together be cited as the Irrigation Division of Meniko Rules

1932 to 1940.

2. Rule 5 of the principal Rules is hereby deleted and the following Rule is substituted therefor:

"5. Every proprietor mentioned in the list shall pay a rate not exceeding the prescribed from time to time by the "5. Every proprietor mentioned in the list shall pay a rate not exceeding ten shillings per annum, as may be prescribed from time to time by the Committee for every Government donum of land owned by such proprietor which is benefited or is capable of being benefited by the works."

3. The principal Rules are hereby amended by the insertion immediately after Rule 5 of the following Rule:

"5A. The Committee shall distribute the water from time to time to every exercister in proportion to the number of donums of land to be invited by

proprietor in proportion to the number of donums of land to be irrigated by each proprietor, having due regard to the quantity of water available."
