**No. 421. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.**

**ORDER OF REQUISITION UNDER REGULATION 66.**

I, the Governor, in exercise of the powers conferred by Regulation 66 of the Defence Regulations, 1940 to (No. 3) 1940, do hereby order the requisition of eight air-rifles (Club Model) the property of Messrs. Simmons Brothers, Nicosia, now lying in the Custom House, Famagusta.

2. Captain H. W. Skinner, Quartermaster, Cyprus Volunteer Force, is hereby authorized to take delivery of the said air-rifles.

**THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.**

**REGULATION MADE BY THE GOVERNOR UNDER SECTION 1.**

I, the Governor, in exercise of the powers conferred by section 1 of the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following Regulation:—

The operation of Regulation 12 of the Petroleum Regulations, 1940, shall, during the continuance in force of this Regulation, be suspended as from 13th day of November, 1940.

**No. 423. THE BURIALS LAWS, 1896 AND 1937.**

**ORDER MADE UNDER SECTION 14.**

Whereas in pursuance of Notification No. 54 published in Supplement No. 3 to Gazette No. 2711 of the 17th March, 1939, fit and proper sites have been registered in the books of the Land Registry Office as burial-grounds for the burial of the dead by the Moslem Communities of the villages of Linou and Pano and Kato Phlasou and of the village of Ayios Epiphanius (Soleas), respectively:

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 22nd day of November, 1940, no burial shall take place in the burial-ground in lieu whereof the new burial-grounds above referred to have been provided.
