No. 436. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940 to (No. 3) 1940, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Weekly Sales of Sugar) Order, 1940, and shall come into operation on the date of its publication in the Gazette.

2. For the purposes of this Order—
"head of household" means, in the case of a dwelling-house, the head or the person acting as the head of the household, and in the case of any hotel or boarding house the keeper or manager of such hotel or boarding-house.
