No. 438. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE GOVERNOR UNDER REGULATION 70.

I, the Governor, in exercise of the powers conferred by Regulation 70 of the Defence Regulations, 1940 to (No. 3) 1940, do hereby order as follows:—

1. This Order may be cited as the Prohibited Areas (No. 4) Order, 1940, and shall be read as one with the Prohibited Areas Orders, 1940 to (No. 3) 1940, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Prohibited Areas Orders, 1940 to (No. 4) 1940.

2. The Schedule to the principal Order is hereby amended by the insertion after Area No. 4 under the heading of "Nicosia Aerodrome Prohibited Area" of a new Area as described in the Schedule hereto.

SCHEDULE.

POLEMIDHIA CAMP PROHIBITED AREA.

All that area being part of the Polemidhia State Forest in the village of Ayia Phyla in the Limassol District; commencing at Forest Cairn 1 on the north boundary of Plot 358 of Government Survey Plan LIV.41 the boundary proceeds westwards and northwards through Forest Cairns 2, 3, 4, 5, 6, 7, 8 and 9; thence westwards and north-eastwards following the boundaries of and including to the area Plots 167, 168, 164 and 169 of Government Survey Plan LIII.48 to the easterly corner of Plot 169; thence north-eastwards following the south-easterly boundaries of Plots 170 and 171 and the southerly boundary of Plot 147 of the same plan to Forest Cairn 8; thence northerly through Forest Cairns 9, 10 and 11 to Forest Cairn 11A; thence south-easterly through Forest Cairns 16, 17, 18, 19, 20, 21, 22 and 23 to Forest Cairn 24; thence southerly following the westerly boundaries of and excluding from the area Plots 75, 76 and 78 of Government Survey Plan LIV.41 to Forest Cairn 25; thence through Forest Cairns 26 and 27 to Forest Cairn 28; thence westerly to Forest Cairn 29; thence northerly, westerly and southerly following the boundaries of and excluding from the area Plot 336 of Government Survey Plan LIV.41 to Forest Cairn 30; thence westerly to Forest Cairn 31; thence south-westerly and including to the area Plots 344 and 342 of Government Survey Plan LIV.41 to Forest Cairn 32; thence southerly and westerly through Forest Cairns 33, 34, 35 and 36 to point of commencement.
