(3) "Registered chemist and druggist" means any person registered as Chemist or Druggist under the provisions of the Pharmacy Laws, 1900 and 1926.
(4) "Registered importer" means any person registered as a registered importer under the Defence (Drugs) Order, 1940.

Within 8 days of the date of the publication of this Order in the Gazette, every registered chemist and druggist, and every registered importer who, on the date of the publication of this Order, has in his possession or under his control stocks of any quinine for sale shall complete and deliver to the Director a declaration in duplicate in the form set forth in the Schedule hereto in respect of such quinine in his possession or under his control.

4. Every person to whom clause 3 of this Order applies shall permit such person as I, or the Director, may authorize, by writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been, or are being, complied with, or for the purpose of checking the correctness or accuracy of any declaration made by such person under clause 3 of this Order.

5. Any person who-

(a) acts in contravention of the provisions of this Order, or

(b) makes under clause 3 of this Order a declaration which is false in any material particular,

is liable to the penaltics prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 3) 1940.

No. 453. THE CYPRUS PUBLIC LIBRARY LAWS, 1936.

REGULATIONS MADE BY THE COMMITTEE OF MANAGEMENT OF THE CYPRUS PUBLIC LIBRARY.

In exercise of the powers vested in them by the Cyprus Public Library Laws, 1936, the Committee of Management of the Cyprus Public Library, with the approval of the Governor in Council, hereby make the following regulations :-

1. These regulations may be cited as the Cyprus Public Library Regulations, 1940. 2.-(1) The Committee shall be summoned by the Chairman of the Committee to meet at least once in every six months and at other times as often as he shall think necessary, and shall consider all matters concerning the management of the

Library (2) The Chairman of the Committee shall within 3 days summon the Committee

if so requested in writing by three members of the Committee.

(3) At any meeting of the Committee-

(a) three members shall form a quorum;

• (b) in the case of equality of votes the Chairman shall have a casting vote in addition to his own.

3. A person subscribing to the Library not less than £1 yearly shall be deemed to be a subscriber.

4. A person making a donation to the Library of £10 or of books or other publications, works of art or science, or any other articles of the value of £10 may by resolution of the Committee be elected as a life subscriber :

Provided that the Committee shall not be bound to accept any such donation. 5. The general public shall have free access to use the books, magazines, periodicals and newspapers of the Library at all times when the Library is open :

Provided that the Committee or the Librarian may from time to time reserve any room in the Library or any part thereof for the use of subscribers.

6. The Committee or the Librarian may from time to time remove valuable books or other publications, works of art or science, or other articles from the use of subscribers and of the general public, and no book or other article so removed shall be used or touched by any person except with the express permission of the Librarian,

7. No person under the age of 14 years shall enter the Library except with the

permission of the Librarian. 8.---(1) The Committee may permit the room situated on the left of the entrance hall of the Library to be used, either gratuitously or on payment of such fee as the Committee may in each case think fit, and on such conditions as the Committee may in each case think fit, for lectures, meetings or otherwise at times when the

Library is not open as and for the purposes of a Library. (2) Applications for the use of the room aforesaid shall be made to the Librarian and shall state the precise purpose for which it is intended to use the room, the time and duration of such use and the admission fees, if any, which it is proposed to charge.

9.-(1) The Library shall be closed during the month of August and on Sundays

(1) The finally shall be very shall be open between the hours of 10 a.m. and
(2) At other times the Library shall be open between the hours of 10 a.m. and 12 noon every day and also between such further hours as the Committee shall from time to time determine. Notice of such hours shall be posted by order of the Committee in a prominent place on the Library premises.

10. Smoking shall not be permitted on the premises of the Library.

11.--(1) All persons using the premises of the Library for any purpose whatever shall behave in a quiet and orderly manner.

(2) No person shall, on the premises of the Library, talk so loudly or behave in such a way as in the opinion of the Librarian to disturb any other person lawfully using the premises as and for the purposes of a Library.

12. The duties of the Librarian shall be,-

- (a) to take proper care of all books and other articles belonging to the Library, and to arrange them systematically and in good order;
- (b) to keep a full catalogue, in such form as the Committee may from time to time direct, of all books and other articles belonging to the Library;
- (c) to conduct on behalf of the Committee all correspondence relating to the purchase of books, magazines, periodicals and newspapers, the issue of books to borrowers and the return of books issued;
- (d) to issue books to borrowers subject to these regulations, and by all means in his power to ensure the return of such books in good condition;
- to collect and refund deposits on books borrowed and to collect fines in accordance with these regulations;
- (f) to keep a full account, in such form as the Committee may from time to time direct, of all moneys received and disbursed by him in accordance with these regulations;
- (y) to supervise the cleaning of the Library premises and of all books and other articles belonging to the Library;
- (h) to exclude or remove from the Library premises any person whom he has reason to suspect to be suffering from any communicable disease or to be in a verminous or insanitary state or who has committed a breach of the laws or of these regulations or otherwise misconducted himself on the Library premises;
- (i) to report to the Chairman of the Committee all matters which in his opinion require the attention of the Committee;
- generally to supervise the proper management of the Library premises and of all books and other articles belonging to the Library, as the Committee may from time to time direct.

13. No magazine, periodical or newspaper shall be removed from the Library premises :

Provided that bound volumes of magazines, periodicals or newspapers shall be deemed to be books and may be removed from the Library in accordance with the provisions of these regulations.

14.-(1) All books in the Library shall be classified as follows :-

(a) works of reference, valuable books and others which could not easily be replaced, and other books of which the Committee may prohibit the removal from the Library : these shall not be removed from the Library : (b) books which may be removed from the Library on payment of a deposit of 2s., 5s., 10s. or such greater sum as may be specified in the cover of each book.

(2) The Librarian shall, subject to the approval of the Committee, determine the classification and fix the amount of the deposit payable in respect of each book.

15.—(a) Books other than those specified in regulation 14 (1) (a) of these regulations may be borrowed by a subscriber, or at the discretion of the Librarian, on payment of the deposit required, by any other person. The Librarian shall give to the borrower a receipt for the money deposited shewing also the date by which the book must be returned. The borrower shall furnish his address to the Librarian and shall give to him a receipt for each book borrowed.

(b) No person shall be permitted to borrow any book from the Library if by so doing the number of volumes borrowed by him and not yet returned to the Library shall exceed five.

16. Every book borrowed shall be returned to the Library not later than one hour before the closing of the Library on the 14th day after that on which the book was borrowed.

17. If a book is returned in the same condition as that in which it was when borrowed, the Librarian shall at the borrower's request return the money deposited in respect of that book in exchange for the receipt given to the borrower.

18. If a book is returned in damaged condition, the Librarian shall not return the money deposited until the book has been repaired or replaced to his satisfaction. Such repairs or replacement shall be undertaken by the Librarian, and their cost shall be deducted from the money deposited. In the event of replacement the damaged book shall become the property of the borrower.

19.—(a) If a book is not returned within the period specified in regulation 16, the Librarian shall forward by the first post or by hand within 24 hours to the address furnished by the borrower a written notification that the book has not been received and that a fine of 3 piastres has been incurred.

(b) If the book is not returned within a further period of 7 days, the Librarian shall similarly inform the borrower in writing that a further fine of 1s, has been incurred and that he will be fined 1s, for every week or part of a week that the return of the book is delayed.

(c) If the book is not returned within 1 month from the date on which it was first due to be returned, the Librarian shall send a registered letter to the borrower at the address furnished by him informing him that if the book is not returned within a further period of 7 days the Librarian will take such steps as he thinks fit to replace the book at the borrower's expense.

(d) On the expiration of the last-named period the Librarian shall decide whether the book shall be replaced and, if not, at what sum it shall be valued.

(e) On the return or replacement of the book the Librarian shall refund to the borrower on his request the money deposited less the cost of replacement and the fines due from him :

Provided that if any borrower notifies the Librarian that he has lost, damaged or destroyed any book he shall only be liable for the cost of replacement and for any fines which he has incurred up to the receipt of such notification by the Librarian.

20. If any book or other article belonging to the Library is damaged or destroyed on the Library premises, the Librarian shall determine the responsibility therefor and shall at his discretion repair or replace the article damaged or destroyed and shall collect from the person responsible the cost of such repairs or replacement.

21. In all cases of dispute as to necessity or cost of repairs or replacement or as to the value of damage caused or as to the amount of fines incurred the decision of the Librarian shall be binding, subject to an appeal to the Committee, whose decision shall be final.

22. No person owing any money under these regulations shall be permitted to make any use of the Library until his debt has been paid in full to the satisfaction of the Librarian.

23. Any borrower may on payment of 2 piastres reserve any book which is out of the Library for his use on its return. On its return a notification shall be sent to him at the address which he specifies informing him that the book is held at his disposal for four complete weekdays after the despatch of the notification. During these four days the book shall not be taken out of the Library by any other person.

Any committee or proprietor of a lending library approved by the Committee, or any Municipal Council other than that of Nicosia, may borrow such number of books on such security as the Committee may determine : Provided that any book for which the Librarian has had a request shall be returned

Provided that any book for which the Librarian has had a request shall be returned within three weeks of the despatch of a notification by the Librarian, subject to the penalties provided in regulation 19. (M.P. 1013/27.)
