**No. 454.** BY THE GOVERNOR.  
A PROCLAMATION.

Whereas by a Proclamation made the 22nd day of September, 1938, and published in the *Gazette* of the 23rd day of September, 1938, (hereinafter called "the First Proclamation"), it was ordered and proclaimed that on and after the 1st day of January, 1939, the boundary of the Town of Nicosia should be as set forth in Schedule A to the said Proclamation and that the Town of Nicosia comprised within the said boundary should be divided into quarters as set forth in Schedule B to the said Proclamation:

And whereas by a Proclamation dated the 30th day of December, 1938, and published in the *Gazette* of the 31st day of December, 1938, (hereinafter called "the Second Proclamation"), it was ordered and proclaimed that the First Proclamation should be amended in order to postpone its coming into operation until the 1st day of January, 1940:

And whereas by a Proclamation dated the 27th day of December, 1939, and published in the *Gazette* of the 27th day of December, 1939, (hereinafter called "the Third Proclamation"), it was ordered and proclaimed that the First Proclamation should be further amended in order to postpone its coming into operation until the 1st day of January, 1941:

And whereas it has been made to appear to me desirable that the coming into operation of the First Proclamation should be further postponed for one year:

Now, therefore, in exercise of the powers vested in me by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, do hereby order and proclaim that the First Proclamation as amended by the Second and Third Proclamations shall be further amended by the deletion of the words "1st day of January, 1941" appearing therein and by the substitution therefor of the words "1st day of January, 1942".

Given at Nicosia, this 16th day of December, 1940.

**No. 455. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.**

ORDER IN COUNCIL No. 1979

MADE UNDER SECTION 116 (a) (i).

*Authority to the Council of the Municipal Corporation of Nicosia to contract a loan.*

I, the Governor in Council, in exercise of the powers conferred by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1938, do hereby order as follows:—

1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Nicosia (hereinafter referred to as "the Municipal Corporation"), shall be at liberty to borrow from the Bank of Cyprus Limited (hereinafter referred to as "the lender"), the sum of seven thousand pounds (£7,000) at a rate of interest

not exceeding six per centum (6%) per annum subject to the following terms and conditions, that is to say,—

- (a) that the sum borrowed shall be repayable by the Municipal Corporation to the lender in eight equal annual instalments (comprising sinking fund and interest);
  - (b) that the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on the revenues the annual sum payable as aforesaid in the year to which such estimates relate;
  - (c) that the sum borrowed shall be utilized by the Municipal Corporation for the following purposes, that is to say,—
    - (i) for the purchase of land for the extension of the Municipal Market a sum of £2,000;
    - (ii) for the construction of new sheds, stalls, etc., a sum of £3,000; and
    - (iii) for the construction of public latrines within the municipal limits a sum of £2,000.
2. This Order shall be deemed to have been made on the 10th day of May, 1940.

**No. 456. THE CUSTOMS LAWS, 1936 TO (No. 2) 1940.**

**ORDER IN COUNCIL No. 1980**

MADE UNDER SECTION 59.

W. D. BATTERSHILL,  
Governor.

I, the Governor in Council, in exercise of the powers conferred by section 59 of the Customs Laws, 1936 to (No. 2) 1940, do hereby order as follows:—

1. This Order may be cited as the Export of Goods Prohibition (No. 2) Order, 1940.

2. The export from the Colony of all goods is prohibited save under a licence granted by the Registrar of Co-operative Societies and subject to such terms and conditions as may be specified in such licence: Provided that all goods enumerated in the First Schedule hereto may be exported without a licence to destinations within the British Empire, Palestine and Egypt.

3. Nothing in this Order contained shall apply to any *bona fide* baggage as defined in item 9 of the Second Schedule to the Customs Laws, 1936 to (No. 2) 1940: Provided that such goods are the property of and are accompanied by a passenger and are proved to the satisfaction of the Comptroller of Customs and Inland Revenue to be for the personal use of such passenger, not being any of the goods enumerated in the Second Schedule hereto.

4. The Export of Goods Prohibition Orders, 1940, are hereby revoked.
