Limits of the Municipal Corporation of Karavas.

I, the Governor, in exercise of the powers conferred by section 6 of the Municipal Corporations Laws, 1930 to 1938, do hereby declare that, as from the 1st January, 1941, the limits of the Municipal Corporation of Karavas shall be as set forth in the Schedule hereto and that the limits of the Municipal Corporation of Karavas as set out in the Order in Council, No. 339, dated the 9th February, 1901, and published in the Gazette of the 15th March, 1901, under Notification No. 5513, shall be cancelled as from the said date.

SCHEDULE.

Limits of the Municipal Corporation of Karavas.

The boundary commences at the mouth of the river "Mavrolimni" at the northwestern corner of plot No. 185, Government Survey Plan No. XI/16, locality "Lambousa," on the boundary of the village of Lapithos and on the seashore, and proceeds north-eastwards and south-eastwards along the seashore to the north-east corner of plot No. 57, Government Survey Plan No. XII/10, locality "Ayios Minas", on the boundary of the village of Ayios Yeoryios; thence southwards along the said village boundary to the south-eastern corner of plot No. 61 of the said Plan, locality "Ayios Minas", on the boundary of the village of Trimithi; thence westwards and southwards along the said village boundary to the south-eastern corner of plot No. 147, Government Survey Plan No. XII/18, locality "Katsikoronies", on the boundary of the village of Karmi; thence south-westwards and southwards along the said village boundary to the south-eastern corner of plot No. 2, Government Survey Plan No. XII/26, locality "Paleomonastiron", on the boundary of the village of Phterykha; thence north-westwards along the said village boundary to the south-eastern corner of plot No. 218/1, Government Survey Plan No. XII/17, locality "Khatemi", on the boundary of the village of Elea; thence northwards along the said village boundary to the most eastern point of plot No. 419, Government Survey Plan No. XII/9, on the main road from Kyrenia to Lapithos; thence west words along the said village of the said village wards along the south side of the said main road (which is also the boundary of the village of Elea) to the most northern point of plot No. 432, Government Survey Plan No. XII/9; thence southwards along the said village boundary to the most southern point of plot No. 355, Government Survey Plan No. XII/17, locality "Vrysi", on the boundary of the village of Motidhes; thence north-westwards and southwards along the said village boundary to the south-western corner of plot No. 601, Government Survey Plan No. XI/24, locality "Kapsalia", on the boundary of the village of Paleosophos; thence southwards along the said village boundary to Forest Color No. 2 A ratio of Paleosophos to Said Village boundary to Forest Cairn No. 2, Lapithos-Karavas Forest, at the most northern point of plot No. 134, Government Survey Plan No. XI/40, locality "Gomaristra", on the boundary of the village of Sisklipos; thence north-westwards along the forest delimitation line (which is also the boundary of the village of Sisklipos) to Forest Cairn No. 3, on the boundary of the village of Lapithos; thence north-westwards and northwards along the boundary of the village of Lapithos to the point of commencement.

The area included in all the said boundary is shown coloured red on the Government Survey Plan Serial No. 1194.
