

No. 494. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.

ORDER IN COUNCIL No. 2006

MADE UNDER SECTION 116 (a) (i).

*Authority to the Council of the Municipal Corporation of Nicosia to contract a loan.*W. D. BATTERSHILL,
Governor.

I, the Governor in Council, in exercise of the powers conferred by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1938, do hereby order as follows:—

1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Nicosia (hereinafter referred to as "the Municipal Corporation"), shall be at liberty to borrow from the Bank of Cyprus Limited (hereinafter referred to as "the lender"), the sum of two thousand five hundred pounds (£2,500) at a rate of interest not exceeding six per centum (6%) per annum subject to the following terms and conditions, that is to say,—

- (a) that the sum borrowed shall be repayable by the Municipal Corporation to the lender in eight equal annual instalments (comprising sinking fund and interest);
- (b) that the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on the revenues the annual sum payable as aforesaid in the year to which such estimates relate;
- (c) that the sum borrowed shall be utilized by the Municipal Corporation for the following purposes, that is to say,—
 - (i) for the purchase of land for further extension of the Municipal Market a sum of £1,500; and
 - (ii) for the construction of a work-house a sum of £1,000.

THE CONSTRUCTION OF BUILDINGS, STREETS AND WELLS
ON ARAZI MIRIE LAWS, 1927 TO 1938.

REGULATIONS MADE UNDER SECTION 12.

I, the Governor in Council, in exercise of the powers conferred by section 12 of the Construction of Buildings, Streets and Wells on Arazi Mirie Laws, 1927 to 1938, do hereby make the following regulations:—

1. These regulations may be cited as the Construction of Buildings, Streets and Wells on Arazi Mirie (Amendment) Regulations, 1940, and shall be read as one with the Construction of Buildings, Streets and Wells on Arazi Mirie Regulations, 1938 and 1939, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Construction of Buildings, Streets and Wells on Arazi Mirie Regulations, 1938 to 1940.

2. Regulation 2 of the principal Regulations is hereby amended by the insertion at the end thereof of the following:—

"and also to the villages of Ayii Omoloyitadhes, Engomi, Ayios Dhometios, Orta Keuy, Trakhonas, Omorphita, Beuyuk Kaimakli, and Paliouriotissa, in the Nicosia District, (hereinafter in these regulations referred to as 'the other villages')."

3. The definition "Building Committee" in regulation 3 of the principal Regulations is hereby amended by the insertion at the end thereof of the following:—

"and in the case of the other villages, the Commissioner;".

4. Paragraph (2) of regulation 4 of the principal Regulations is hereby amended by the deletion therefrom of the words "shall be stamped with stamps to the value of five shillings and" (lines 1 and 2).

5. Regulation 4 of the principal Regulations is hereby amended by the addition thereto at the end thereof of the following paragraph:—

"(4) There shall be paid a fee of one pound in respect of every building site or of every part of any existing building into which it is proposed to divide or sub-divide the area of land or the building in respect of which the application is made and such fee shall be paid in stamps to be affixed on the application."

6. The First Schedule to the principal Regulations is hereby amended by the repeal of the words "[Space for stamps to the value of 5s.]" (which occur at the end thereof) and the substitution therefor of the words "[Fee of £.....affixed in stamps.]"

7. The Eighth Schedule to the principal Regulations is hereby repealed and the following substituted therefor:—

" EIGHTH SCHEDULE.

THE TRADES AND INDUSTRIES (REGULATION) LAW, 1937.

REGULATIONS MADE UNDER SECTION 14.

I, the Governor in Council, in exercise of the powers conferred by section 14 of the Trades and Industries (Regulation) Law, 1937, do hereby make the following regulations:—

1. These regulations may be cited as the Regulated Trades (Structural Requirements, Safety, Sanitation and Ventilation) Regulations, 1940.
2. No premises shall be registered and no certificate of registration shall be renewed unless such premises are—

- (a) from a sanitary and hygienic point of view suitable for the purposes of carrying on therein or thereon the regulated trade in respect of which the application for the registration of the premises is made; and
- (b) structurally safe and suitable for the purpose of carrying on therein or thereon the regulated trade in respect of which the application for the registration of the premises is made.
