THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.

ORDER IN COUNCIL No. 1926

MADE UNDER SECTION 78.

W. D. BATTERSHILL,

Governor.

Whereas at a meeting of the Council of the Municipal Corporation of Nicosia (hereinafter called "the Municipal Council") held on the 17th December, 1939, it was decided upon a resolution of the required majority:

- (a) to cede to and register in the name of Savvas Paraskeva Karnapas, of Jerusalem, the area of immovable property set out in Part II of the First Schedule hereto and registered in the name of the Municipal Corporation in exchange for the area of immovable property set out in Part I of the First Schedule hereto which the said Savvas Paraskeva Karnapas has ceded to the Municipal Corporation for the purpose of widening Aeschylos Street; and
- (b) to sell by public auction the area of immovable property set out in the Second Schedule hereto registered and to be registered in the name of the Municipal Corporation:

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 78 of the Municipal Corporations Laws, 1930 to 1938, and with the advice of the Executive Council, is pleased to sanction and hereby sanctions the sale and cession of the immovable properties as hereinbefore mentioned:

Provided that the sale price of the area of immovable property set out in the Second Schedule hereto shall not be less than £300.

FIRST SCHEDULE.

PART I.

(Description of Property to be ceded to the Municipal Corporation.)

All that area being part of plot 155 of sheet XXI.46.6.IX, registered under Registration No. 238 of Tripioti Quarter, Nicosia Town, comprising 266 square feet approximately as shewn under items 4 and 5 and coloured yellow on the Government Survey Plan Serial No. 1203 filed in C.S. M.P. 671/30.

(Description of Property to be ceded by the Municipal Corporation.)

All that area being part of plot 154 of sheet XXI.46.6.IX, registered under Registration No. 236 of Tripioti Quarter, Nicosia Town, comprising 512 square feet approximately as shewn under item 3 and coloured blue on the Government Survey Plan Serial No. 1203 filed in C.S. M.P. 671/30.

SECOND SCHEDULE.

(Description of Property to be sold.)

All that area being parts of plots 154, 154/1 and 155 of sheet XXI.46.6.IX, registered under Registrations Nos. 236, 237 and 238 (part) of Tripioti Quarter, Nicosia Town, respectively, comprising 1,478 square feet approximately as shewn under items 2 and 5 and coloured violet and yellow (b) respectively on the Government Survey Plan Serial No. 1203 filed in C.S. M.P. 671/30.

No. 70. THE BURIALS LAWS, 1896 AND 1937.

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of Notification No. 150 published in Supplement No. 3 to Gazette No. 2668 of the 5th August, 1938, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Moslem Community of the village of Kokkina at its new site in the District of Nicosia:

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 4th day of March, 1940, no burial shall take place in the burial-ground situated at the old site of the said village, in lieu whereof the new burial-ground above referred to has been provided.
