THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.

NOTIFICATION UNDER SECTION 121.

Whereas the properties described in the Schedule hereto are required by the Mayor, Deputy Mayor, Councillors and Townsmen of Lefka (hereinafter referred to as "the Municipal Corporation") for the public purpose of widening streets within the Municipal limits of Lefka :

And whereas the formalities prescribed by sections 119 and 120 of the Municipal Corporations Laws, 1930 to 1938, have been complied with :

And whereas His Excellency the Governor has approved of the plan submitted in that behalf and considers it expedient, having regard to all the circumstances, that the Municipal Corporation should be permitted to acquire the said properties for the above public purpose :

Now, therefore, in exercise of the powers vested in him by section 121 of the Municipal Corporations Laws, 1930 to 1938, His Excellency the Governor has been pleased to sanction and hereby sanctions the acquisition of the properties described in the Schedule hereto by the Municipal Corporation.
