THE POST OFFICE LAWS, 1881 TO 1933.

ORDER IN COUNCIL No. 1927

MADE UNDER SECTION 6.

In exercise of the powers vested in him by section 6 of the Post Office Laws, 1881 to 1933, His Excellency the Governor, with the advice of the Executive Council, is pleased to order and it is hereby ordered as follows:—

1. This Order may be cited as the Post Office (Air Mail Rate of Postage) Order, 1940.

2. There shall be charged a combined Postage and Air fee, in addition to late and/or registration fees, at the rates set forth in the second and third columns of the Schedule hereto, on letters, printed papers, commercial papers, samples and postcards intended for transmission by air mail to any of the countries of destination enumerated in the first column of the said Schedule, such transmission to be effected—

- (a) by surface route from the Colony to Egypt or Palestine; and
- (b) from Egypt or Palestine to the country of destination either wholly by air or partially by air and partially by surface route.

3. The Post Office (Air Mail Rate of Postage) Order, 1939, is hereby revoked.

THE EMERGENCY POWERS (CYPRUS DEFENCE)  
REGULATIONS, 1939 TO (No. 1) 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939 to (No. 1) 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Returns of Stocks of Barley) Order, 1940.

2. Within twenty days from the date of the publication of this Order in the *Gazette*, every person (whether such person is a merchant, importer, dealer or otherwise) who has in his possession or under his control any quantity of barley exceeding in the aggregate one kilé shall complete and deliver to—

(a) in the case of a person residing in or carrying on business in a town, the Commissioner of the District in which such town is situated, or
