THE EMERGENCY POWERS (CYPRUS DEFENCE) REGULATIONS, 1939 TO (No. 1) 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939 to (No. 1) 1939, I hereby order as follows:

1. This Order may be cited as the Defence (Lands Sown with Wheat

and Barley) (Returns) Order, 1940.

- 2. Within twenty days from the date of the publication of this Order in the Gazette, every person who, since the 1st day of October, 1939, has sown any lands with wheat or barley, whether as owner or lessee or cultivator in partnership of such lands or otherwise, shall declare to the Mukhtar of the town, village or quarter within the limits of which such lands are situated the number of Government donums of land sown with wheat and/or barley, as the case may be.
 - 3. Any person who—

(a) acts in contravention of, or fails to comply with, the provisions of clause 2 of this Order, or

(b) makes, under clause 2 of this Order, a declaration which is false in any material particular, shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939 to (No. 1) 1939.
