THE EMERGENCY POWERS (CYPRUS DEFENCE)
REGULATIONS, 1939 TO (No. 1) 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939 to (No. 1) 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Sale Prices of Scheduled Articles) Amendment (No. 2) Order, 1940, and shall be read as one with the Defence (Control of Sale Prices of Scheduled Articles) Orders, 1940, (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Defence (Control of Sale Prices of Scheduled Articles) Orders, 1940 to (No. 2) 1940.

2. Part 1 of the First Schedule to the Principal Order is hereby amended by the insertion of the following paragraphs at the end thereof:—

"SPECIAL MODIFICATIONS:—

- (1) Where the Commissioner of the District is satisfied that any person holds stocks of imported wheat, the cost price of which exceeds the price shown in the second column of this Part of this Schedule, such Commissioner may by an instrument under his hand authorize the person holding such stocks to sell the imported wheat to a person named in the instrument in such quantities, at such higher price and subject to any other terms and conditions as may be specified in such instrument.
- (2) Any sale of imported wheat made in pursuance of, and in accordance with, any instrument issued under paragraph (1) hereof, shall be deemed to be a sale made under the provisions of this Order."
