THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1. These regulations may be cited as the Defence (Amendment No. 1) Regulations, 1941, and shall be read as one with the Defence Regulations, 1940 to (No. 4) 1940, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence Regulations, 1940 to (No. 1) 1941.

2. Regulation 105 of the principal Regulations is hereby amended by the addition thereto of the following paragraph as paragraph (3):—

"(3) Any reference to any regulation revoked by these regulations contained in any Law or public instrument or in any order or document issued or made thereunder shall, unless the contrary intention appears, be construed as a reference to the corresponding regulation of these regulations whether the revoked regulation has been re-introduced in these regulations with or without modification."

3. These regulations shall be deemed to have come into operation on the 3rd day of June, 1940.
