In exercise of the powers vested in him by the Post Office Laws, 1881 to 1933 , His Excellency the Governor, on the representation of the Postmaster-General, has been pleased to give the following directions :-

1. On and from the 16 th May, 1941, the limits of size and weight for the various classes of postal packets conveyed by post and the conditions under which such postal packets posted, or conveyed or delivered by post shall be as follows :-

2. There shall not be posted, or conveyed or delivered by post -
(1) Articles which, from their nature or by their packing, may expose postal officials to danger, or may soil or damage correspondence;
(2) Articles liable to customs duty and sent as samples in quantities with the intention of avoiding the payment of such duty;
(3) Opium, morphine, cocaine, and other narcotics (except by Parcel Post);
(4) Articles of which the importation or the circulation is forbidden in the country of destination;
(5) Living animals, except bees, leeches, silk-worms and parasites and destroyers of noxious insects used for the purpose of controlling these insects and exchanged between officially recognized institutions;
(6) Explosive, inflammable or dangerous substances;
(7) Obscene, immoral or grossly offensive communications, marks, designs, prints, photographs or other articles;
(8) Packets of which the address portion has been marked off into several divisions intended to contain successive addresses;
(9) Packets consisting of or containing two or more postal packets, of the same or of different descriptions, addressed to different persons at different addresses;
(10) Coin exceeding $£ 5$ in value; except coins used or designed for ornamental purposes and declared as such;
(11) Gold bullion exceeding $£ 5$ in value; and
(12) Valuable articles (for example coin, bank-notes, currency notes, negotiable instruments payable to bearer, platinum, gold or silver, manufactured or not, precious stones, jewels and other precious articles) if sent in unregistered packets.
N.B.-The conditions under which articles may be forwarded at the reduced rates for Postcards, Commereial Papers, Printed Papers, Samples and Small Packets can be ascertained at any Post Office.
3. Notifications Nos. 2877, 623 and 1392, published in the Cyprus Gazettes Nos. 482, 1261 and 2416, dated, respectively, 25th May, 1895, 29th December, 1916, and 31st December, 1934, are hereby cancelled.
