THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1941.

ORDER MADE BY THE COMPETENT AUTFORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of fregulation 61 of the Defence Regulations, 1940 to (No. 1) 1941, I hereby order as follows :---

1. This Order may be cited as the Defence (Sale of Sparking Plugs Control) Order, 1941.

2. For the purposes of this Order— "Sparking plugs" means unused sparking plugs.

"Dealer in sparking plugs" means any person who has in his possession or under his control any sparking plugs for the purpose of sale by retail or by wholesale.

3. Within three days from the date of the publication of this Order, every dealer in sparking plugs and every person who has in his possession or under his control any sparking plugs exceeding two in number shall complete and deliver to me a declaration in the form set forth in the First Schedule hereto in respect of the sparking plugs in his possession or under his control.

4.-(1) From and after the 14th May, 1941, no person shall withdraw any sparking plugs from the Customs save under a special permit issued under my hand.

(2) Every special permit issued under the provisions of paragraph (1) hereof may contain such terms and conditions (including the price at which such sparking plugs are to be sold or purchased) as may be specified therein.

5. Any person who wants to buy or otherwise acquire any sparking plugs shall forward to me at Nicosia an application in the form set forth in the Second Schedule hereto. Whereupon I may grant to the holder of such certificate a permit to buy or otherwise acquire such sparking plugs as may be specified in the permit.

6. From and after the 14th May, 1941 :

- (a) No person shall buy or otherwise acquire any sparking plugs unless he is in possession of a permit issued by me under the provisions of clause 5 above.
- (b) No person shall sell or otherwise dispose of any sparking plugs except to a person who is in possession of a permit issued by me under the provisions of clause 5 above.

7. Every dealer in sparking plugs shall exhibit and keep exhibited at a conspicuous place on his premises a list showing the maximum price at which such sparking plugs are offered for sale.

8. Every dealer in sparking plugs shall keep on his premises a register showing the name of the purchaser of every sparking plug, the number of the permit allowing such purchase and the price at which the sparking plug was sold.

9. Any person who-

- (a) acts in contravention of the provisions of this Order or of any of the terms and conditions specified in any permit issued under this Order ; or
- (b) makes under clause 3 of this Order any declaration which is false in any material particular; or (c) makes under clause 5 any application which is false in any material
- particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1941.
