I, the Governor, in exercise of the powers conferred by regulation 33A of the Defence Regulations, 1940 to (No. 2) 1941, do hereby order that the said regulation be applied to every town, village, area and place in the Colony.

No. 135. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1941.

ORDER MADE UNDER REGULATION 55.

I, the Governor, in exercise of the powers conferred by regulation 55 of the Defence Regulations, 1940 to (No. 2) 1941, do hereby order as follows:—

1. This Order may be cited as the Defence (Control of Use of Mechanically Propelled Vehicles on Roads) Order, 1941.

2. From and after the 12th day of June, 1941, no person shall use any mechanically propelled road vehicle on any road in the Colony between the hours of 8 p.m. and 6 a.m. without permission in writing from the Police Officer in charge of a District.

3. Nothing in this Order shall apply to vehicles used exclusively by His Majesty's Forces or by any member of the Cyprus Police Force or Air Raid Precautions Organization on duty as such.

No. 136. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1941.

ORDER MADE UNDER REGULATION 39A.

I, the Governor, in exercise of the powers conferred by regulation 39A of the Defence Regulations, 1940 to (No. 2) 1941, do hereby order as follows:—

1. This Order may be cited as the Motor Vehicles (Control) Order, 1941.

2. From and after the 12th day of June, 1941, all mechanically propelled road vehicles shall be rendered, when not being driven, incapable of use by unauthorized persons by the removal therefrom of such parts of the mechanism as may, from time to time, be directed by the Police Officer in charge of the District.

3. Nothing in this Order shall apply to vehicles used exclusively by His Majesty's Forces or by any member of the Cyprus Police Force or Air Raid Precautions Organization on duty as such.

No. 137. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 2) 1941, I hereby order as follows:—

1. This Order may be cited as the Motor Vehicles and Pedal Bicycles (Control of Storage and Sale of Spare Parts) Order, 1941.

2. From and after the 12th day of June, 1941, every person who is a dealer in or holds a stock of motor vehicle or pedal bicycle parts or accessories shall store such parts or accessories as may be specified by the Police Officer in charge of the District at such place or places as may be ordered by him.

3. No such parts or accessories shall be disposed of except with the written permission of the Police Officer in charge of the District.
