THE PETROLEUM LAW, 1939.

REGULATIONS MADE UNDER SECTION 9.

I, the Governor in Council, in exercise of the powers conferred by section 9 of the Petroleum Law, 1939, do hereby make the following regulations:—

1. These regulations may be cited as the Petroleum (Amendment) Regulations, 1941, and shall be read as one with the Petroleum Regulations, 1940 to (No. 1) 1940, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Petroleum Regulations, 1940 to 1941.

2. Regulation 17 of the principal regulations is hereby amended by the insertion immediately after the first paragraph thereof of the following proviso:—

"Provided that vessels fitted with gas ejectors and gas tight hatches may remain alongside the pier or wharf, in which case neither wire ropes nor anchors shall be used as moorings."

No. 146. THE DEFENCE REGULATIONS, 1940 TO (No. 2) 1941.

DELEGATION OF POWER UNDER PARAGRAPH (5) OF REGULATION 66.

In exercise of the powers vested in him by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 2) 1941, His Excellency the Governor has been pleased to depute and hereby deposes the persons named in the second column of the Schedule hereto to exercise and perform on the Governor's behalf the powers mentioned in the first column of the said Schedule which the Governor is empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 2) 1941, in addition to the persons holding the offices designated in the Notification published in Supplement No. 3 to the *Gazette* of the 23rd August, 1940, under No. 329.

THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES) CONSOLIDATION ORDERS, 1940.

NOTICE No. 32 UNDER CLAUSE 13.

The Schedule is hereby amended by the deletion therefrom of Part 3 and the substitution therefor of the following part:—

"PART 3.—IMPORTED FLOUR.

Imported flour ..	<i>Retail Price</i> 6½ piastres per oke.	<i>Wholesale Price</i> £1. 16s. per bag of approximately 53 okes.

In this Part of the Schedule—

the term 'wholesale' means sale or purchase of imported flour in quantities of not less than one bag of approximately 53 okes at any one time or at any single transaction."
