No. 152. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1941.

ORDER MADE UNDER REGULATION 55.

I, the Governor, in exercise of the powers conferred by regulation 55 of the Defence Regulations, 1940 to (No. 3) 1941, and of every other power hereunto enabling, do hereby order as follows:—

1. This Order may be cited as the Defence (Control of Use of Mechanically Propelled Vehicles on Roads) (Amendment) Order, 1941, and shall be read as one with the Defence (Control of Use of Mechanically Propelled Vehicles on Roads) Order, 1941, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Control of Use of Mechanically Propelled Vehicles on Roads) Orders, 1941.

2. Clause 2 of the principal Order shall be amended by the deletion therefrom of the figure and letters "8 p.m." and the substitution therefor of the figures and letters "10 p.m."

DELEGATION OF POWER UNDER PARAGRAPH (5) OF REGULATION 66.
