# THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1941.

## ORDER BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the 

1. This Order may be cited as the Defence (Cyprus Grown Wheat Control) Order, 1941.

2. In this Order-

wheat" means Cyprus grown wheat;

"Mukhtar" means the Mukhtar of the village or quarter in which the wheat is situated;

producer" means any person who, since 1st September, 1939, has cultivated and produced any wheat either by his own labour or through his agents or servants.

3. Within one week of the date of the publication of this Order in the Gazette every person who has in his possession or under his control any quantity of wheat whether threshed or unthreshed shall complete and deliver to the Mukhtar a return, in the form set forth in the Schedule hereto, in respect of the total quantity of wheat in his possession or under his control.

4. On and from the date of the publication of this Order no person, shall, save under a written permit issued by the Commissioner of the District or by any other person authorized by the Commissioner of the District in that behalf,

(a) remove or permit to be removed from any premises any wheat:

Provided that any producer may remove any wheat from his threshingfloor to any premises in his possession or under his control;

(b) purchase, sell or otherwise dispose of any wheat;(c) mix or permit to be mixed any wheat with any grain or other substance.

5. Every person shall permit any member of the Cyprus Police, any Assistant Agricultural Superintendent, any Agricultural Officer or any person authorized by the Commissioner of the District in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this Order.

6. Any person who-

- (a) acts in contravention of, or fails to comply with, any of the provisions of this Order; or
- (b) makes, under any of the provisions of this Order, a return which is false in any material particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 3) 1941.
