THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 1.

I, the Governor, in exercise of the powers conferred by section 1 of the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1. The Municipal Corporations Laws, 1930 to 1941, (Suspension of Certain Provisions) Regulations, 1941, are hereby revoked.

2. These regulations shall be deemed to have come into operation on the 1st day of June, 1941.

THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 1.

I, the Governor, in exercise of the powers conferred by section 1 of the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1.—(1) These regulations may be cited as the Amendment of the Municipal Corporations (Appointment of Councils) Laws, 1938 and 1940, Regulations (No. 2) 1941.

(2) The Interpretation Law, 1935, shall apply to the interpretation of these regulations as it applies to the interpretation of a Law.

2. The proviso to section 9 of the Municipal Corporations (Appointment of Councils) Laws, 1938 and 1940, is hereby amended by the deletion of the words "thirtieth day of June, 1941," and the substitution therefor of the words "first day of January, 1942."

3. The Amendment of the Municipal Corporations (Appointment of Councils) Laws, 1938 and 1940, Regulations, 1941, are hereby revoked.
