THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES)
CONSOLIDATION ORDERS, 1940.

NOTICE No. 38 UNDER CLAUSE 13.

The Schedule is hereby amended by the deletion therefrom of Part 26 and the substitution therefor of the following part:—

“PART 26.—WHOLE WHEAT FLOUR.

(1)	(2)
1. All towns	155 paras per oke.
2. All villages when purchased in towns in quantities of not less than one bag of 50 okes in respect of which a receipt has been given by the municipal weigher of the Municipality where the purchase has been made ..	155 " "
3. All villages when milled at any mill situated at any village	151 " "

Definition: ‘Whole wheat flour’ shall have the same meaning as in the Defence (Sale of Barley Flour and Wheat Flour) Order, 1940.

Modifications:

- (a) Where whole wheat flour purchased in any town is sold in any village there may be added to the maximum price of 155 paras per oke, 2 paras per oke for every 10 miles or part thereof by which such village is distant from the principal town of the District in which such village is situated: Provided that in no case such addition shall exceed 10 paras per oke.
- (b) Where whole wheat flour is purchased in a town for sale in another town in quantities of not less than one bag of 50 okes in respect of which a receipt has been given by the Municipal Weigher of the Municipality where the purchase has been made, there may be added to the maximum price of 155 paras per oke, 2 paras per oke for every 10 miles or part thereof by which the town in which the whole wheat flour is purchased is distant from the town in which it is sold: Provided that in no case such addition shall exceed 10 paras per oke.
- (c) Where whole wheat flour milled at any mill situated at any village is sold in any village there may be added to the maximum price of 151 paras per oke, 2 paras per oke for every 10 miles or part thereof by which such village is distant from the principal town of the District in which such village is situated: Provided that in no case such addition shall exceed 10 paras per oke.”
