THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1941.

ORDER IN COUNCIL No. 2018

MADE UNDER SECTION 78.

W. D. BATTERSHILL, Governor.

Whereas the Mayor, Deputy Mayor, Councillors and Townsmen of Larnaca, (hereinafter referred to as "the Municipal Corporation"), have decided by a unanimous resolution of the members of the Council to transfer into the name of the Government of Cyprus, (hereinafter referred to as "the Government"), the immovable property described in the First Schedule hereto on condition that the Government shall pay to the Municipal Corporation the sum of one thousand pounds (£1,000) and shall transfer into the name of the Municipal Corporation the immovable property described in the Second Schedule hereto:

Now, therefore, His Excellency the Governor in Council, in exercise of the powers

vested in him by section 78 of the Municipal Corporations Laws, 1930 to 1941, is pleased to sanction and hereby sanctions the transfer by the Municipal Corporation of the immovable property described in the First Schedule hereto into the name of the Government on condition that the Government shall pay to the Municipal Corporation the sum of one thousand pounds (£1,000) and shall transfer into the name of the Municipal Corporation the immovable property described in the Second Schedule hereto.

FIRST SCHEDULE.

Immovable property to be transferred by the Municipal Corporation into the name of the Government :-

The Petrol Store situated within the limits of Larnaca Town consisting of one large store, one small divided into four smaller stores, two rooms, one veranda

and yard and bounded by-

Plot 100 Zenon Dimitraki Pierides and Dimitraki Zenon Pierides of Scala; plot 128 Zenon Dimitraki Pierides of Scala and Yeorghios Panayoti Sardou of New York; foreshore; street; plot 132; plot 131; plot 130 Panayotis Haji Antoni Sardou, more particularly defined as plot No. 99 of Block D of the Government Survey Plan of Larnaca Town, registered in the name of the Municipal Corporation of Larnaca Town under Registration No. D.94 of the 30th December, 1939.

SECOND SCHEDULE.

Immovable property to be transferred by the Government into the name of the

Municipal Corporation :-

The store registered in the name of the Government of Cyprus under Registration No. C.337 of the 23rd February, 1940, of Scala, plot 339 of Block C, consisting of one store and a piece of yard on King George V Square, and bounded by-North and East: Government of Cyprus; South: King George V Square; and

West: Government of Cyprus.
