**No. 223. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1941.**

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 3) 1941, I hereby order as follows:—

1. This Order may be cited as the Defence (Returns of Stocks of Local Olive Oil) Order, 1941.

2. Within 3 days from the date of the publication of this Order every person who has in his possession or under his control any local olive oil in excess of 25 litres shall complete and deliver to me a declaration in the form set forth in the First Schedule hereto in respect of the local olive oil in his possession or under his control.

3. Not later than six days after the last day of each month, commencing from the month of September, 1941, any person who has in his possession or under his control any local olive oil in excess of 25 litres, shall complete and deliver to me a return containing the particulars set forth in the Second Schedule hereto in respect of his dealings in local olive oil.

4. Every person shall permit such person as the Commissioner of the District may authorize by writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this Order.

5. Any person who—

(a) acts in contravention of, or fails to comply with, any of the provisions of this Order; or

(b) makes, under any of the provisions of this Order, a declaration or return which is false in any material particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 3) 1941.

**No. 224. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1941.**

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 3) 1941, I hereby order as follows:—

1. This Order may be cited as the Defence (Returns of Confirmed Orders of Foodstuffs) Order, 1941.

2. In this Order "Foodstuffs" means every article used for food and drink by man, other than drugs or water, and any article which ordinarily enters into or is used in the preparation of human food including flavouring matters and condiments, in respect of which an order has been placed abroad with a view to their importation into the Colony.

3. Within 3 days of the publication of this Order every person, whether in possession of an import licence or not, who has received information that any order placed by him for any foodstuffs has been confirmed by his supplier shall complete and deliver to me a return in the form set forth in the Schedule hereto.

4. From and after the date of the publication of this Order every person, whether in possession of an import licence or not, who receives information from his supplier that any order placed by him for any foodstuffs has been confirmed shall, within three days of the receipt of such information, complete and deliver to me a declaration in the form set forth in the Schedule hereto.

5. Any person who—

(a) acts in contravention of this Order; or

(b) makes under clause 3 or clause 4 of this Order any return which is false in any material particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 3) 1941.
