DELEGATION OF POWER UNDER PARAGRAPH (5) OF REGULATION 66.

I, the Acting Governor, in exercise of the powers conferred upon the Governor by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to No. (3) 1941, do hereby depute the persons for the time being holding the offices designated in the second column of the Schedule hereto to exercise and perform on the Governor's behalf the powers mentioned in the first column of the said Schedule which the Governor is empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 3) 1941.

2. The Notification No. 123, published in Supplement No. 3 to the *Gazette* of the 30th May, 1941, is hereby revoked.

No. 233. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 3) 1941, I hereby order as follows :—

1. This Order may be cited as the Defence (Armed Forces Meal Hours) Order, 1941.

2. In this Order-

"Meal" means any cooked food but does not include bread, biscuits, cakes and small pieces of uncooked food usually served with drinks and not separately paid for.

"Restaurant" means any place where meals are served on payment.

3. On and from the date of the publication of this Order no person shall serve any meal to any member of His Majesty's Forces in any restaurant, except between the hours of 12 noon and 2 p.m. and 7 p.m. and 9 p.m.

4. This Order shall not apply to meals served to any member of His Majesty's Forces in any hotel in which he is a resident.

5. Any person who acts in contravention of, or fails to comply with, any of the provisions of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 3) 1941.
