

No. 24. THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

In exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, His Excellency the Governor is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Asha, in the District of Famagusta.

SCHEDULE.

The area lying within the following boundaries, that is to say:—

The boundary commences at the north-western corner of plot No. 67 of the Government Survey plan No. XXXI/7, on the road from the village of Aphanía to the village of Asha, and proceeds eastwards along the boundaries of, and including, plots Nos. 67, 77, 100, 117, 118, 120, 124, 148, 160, 159, 158, 172, 171, 212, 200, 205, 204 and 211 of the said plan, locality "Hilio Maghoussa", plots Nos. 19, 20, 22, 34, 39, 35, 36, 37, 77, 78, 82, 299, 298, 146, 145 and 144 of the Government Survey plan No. XXXI/8, locality "Katalimata", to the most northern point of plot No. 144 of the said plan, on the road from the village of Asha to the village of Vatili; thence south-eastwards along the said road to the junction of roads at the north-eastern corner of plot No. 202 of the said plan, on the boundary of the village of Asha; thence southwards, westwards and northwards along the said village boundary to the most southern point of plot No. 344 of the Government Survey plan No. XXXI/7, locality "Almiros", at the junction of two roads; thence north-westwards and north-eastwards along a road and along the boundaries of, and including, plots 344, 343, 342, 32, 34 and 35 to the point of commencement; all which said area is 4,686 donums or thereabouts as shown edged in red on the plan filed in the D.L.R.S. M.P. 412/40.

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Dhromolaxia, in the District of Larnaca.

SCHEDULE.

The area lying within the following boundaries, that is to say:—

The boundary commences at the north-western corner of plot No. 52 of the Government Survey plan No. L/7, locality "Pasha Chiftlik", on the right bank of a stream, and proceeds eastwards along the said stream to the most eastern point of plot No. 59 of the said plan; thence southwards and eastwards along the western and southern boundary of plot No. 60 of the said plan to the most southern point of the said plot on a footpath leading from the Salt Lake to the village of Dhromolaxia; thence south-eastwards and south-westwards along the said footpath to the most southern point of plot No. 105 of the Government Survey plan No. L/15; thence north-westwards along the boundaries of, and including, plots Nos. 104, 102 and 101 of the said plan to the south-western corner of the last mentioned plot on a footpath leading from the village of Dhromolaxia to the locality "Trypes"; thence north-eastwards and north-westwards along the said footpath to the south-eastern corner of plot No. 54 of the Government Survey plan No. L/7; thence westwards along the boundaries of, and including, plots Nos. 54 and 52 of the said plan to the point of commencement; all which said area is 797 donums or thereabouts as shown edged in red on the plan filed in the D.L.R.S. M.P. 462/40.
