

No. 254. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 3) 1941, I hereby order as follows:—

1. This Order may be cited as the Defence (Returns of Tarpaulins) Order, 1941.
2. In this Order—

“ tarpaulin ” means a rainproof covering for merchandise measuring not less than 9 feet by 12 feet.

3. On or before the 28th October, 1941, every person who has in his possession or under his control any tarpaulins shall complete and deliver to the Superintendent, Government Railway, at Famagusta, a return in the form set forth in the Schedule to this Order.

4. Any person who—

(a) acts in contravention of the provisions of this Order; or

(b) makes under clause 3 of this Order any return which is false in any material particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 3) 1941.

No. 255. The Irrigation Divisions (Villages) Law, 1938.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, 1938, the following rules made by the Committee of the Irrigation Division of Trikomo, “Kyparissia”, in the District of Famagusta, are published in the *Gazette*.

IRRIGATION DIVISION OF TRIKOMO, “KYPARISSIA”.

Rules.

1. These rules may be cited as the Irrigation Division of Trikomo, “Kyparissia”, Rules, 1941.

2. In these rules, unless the context otherwise requires—

“ Commissioner ” means the Commissioner of the District of Famagusta;

“ Committee ” means the Committee of the Irrigation Division;

“ Irrigation Division ” means the Irrigation Division of Trikomo, “Kyparissia”.

“ Law ” means the Irrigation Divisions (Villages) Law, 1938;

“ list ” means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared under the provisions of section 15 of the Law as finally settled under the provisions of section 16 of the Law;

“ works ” means the irrigation works of the Irrigation Division.
