

**No. 266. THE CYPRUS GOVERNMENT RAILWAY LAW, 1906.**

## REGULATIONS MADE UNDER SECTION 2.

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor by section 2 of the Cyprus Government Railway Law, 1906, do hereby make the following regulations:—

1. These regulations may be cited as the Railway (Amendment No. 4) Regulations, 1941, and shall be read as one with the Railway Regulations, 1939 to (No. 3) 1941, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Railway Regulations, 1939 to (No. 4) 1941.

2. Part VI of the First Schedule to the principal Regulations (under heading "Miscellaneous Charges") is hereby amended as follows:—

- (a) by the deletion in paragraph (8) (i) of the figures "4½p." and "3p." and the substitution therefor of the figures "7p." and "5p.", respectively;
- (b) by the deletion in paragraph (8) (ii) of the figures "1s." and "3p." and the substitution therefor of the figures "1s. 4½p." and "6p.", respectively.

**No. 268. THE DEFENCE REGULATIONS, 1940 TO (No. 5) 1941.**

## ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 5) 1941, I hereby order as follows:—

1. This Order may be cited as the Defence (Returns of Naphthaline) Order, 1941.
2. On or before the 17th November, 1941, every person who has in his possession or under his control any naphthaline in excess of 20 okes shall complete and deliver to me a declaration in the form set forth in the First Schedule hereto in respect of the naphthaline in his possession or under his control.
3. Not later than six days after the last day of each month commencing from the month of December, 1941, any person who has in his possession or under his control any naphthaline in excess of 20 okes shall complete and deliver to me a return containing the particulars set forth in the Second Schedule hereto in respect of his dealings in naphthaline.
4. Every person shall permit such person as I or the Commissioner of the District may authorize by writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this Order.
5. Any person who—
  - (a) acts in contravention of, or fails to comply with, any of the provisions of this Order, or
  - (b) makes, under any of the provisions of this Order, a declaration or return which is false in any material particular,
 is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 5) 1941.
