THE DEFENCE REGULATIONS, 1940 TO (No. 5) 1941. No. 276.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 5) 1941, I hereby order as follows :-

1. This Order may be cited as the Defence (Control of Sale Prices of Scheduled Articles) Consolidation (Amendment) (No. 1) Order, 1941, and shall be read as one with the Defence (Control of Sale Prices of Scheduled Articles) Consolidation *Gazettee*: Orders, 1940, (hereinafter called "the principal Order"), and the principal Order Supplement and this Order may together be cited as the Defence (Control of Sale Prices of No. 3: Scheduled Articles) Consolidation Orders, 1940 and 1941.

Supplement 3.7.1940 23.8.1940

2. Clause 10 of the principal Order is hereby revoked and the following clause substituted therefor :-

"10.-(1) Every person who exposes for sale, or holds a stock of, any scheduled article shall exhibit and keep exhibited one copy of the official list at a conspicuous place inside his premises and one copy outside his premises, showing the maximum price at which each such scheduled article is offered for sale.

(2) The requisite number of copies of official lists shall be distributed free of charge to persons who satisfy me that they are persons who deal in scheduled articles within the scope of paragraph (1) of this clause.

(3) For the purposes of this clause-

'official list' means the latest list or amendment slip published by my authority, showing the prices at which scheduled articles may be sold or purchased."

1. This Order may be cited as the Defence (Treatment of Cyprus Grown Wheat) Order, 1941.

2. In this Order-

"wheat" means Cyprus grown wheat.

3. On and from the date of the publication of this Order no person shall mill or treat or permit to be milled or treated any wheat in such a manner as to render it unsuitable for use as seed.

4. Any person who acts in contravention of, or fails to comply with, any of the provisions of this Order is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 5) 1941.
