## No. 283. THE DEFENCE REGULATIONS, 1940 TO (No. 5) 1941.

Order made by the Competent Authortty under Regulation 61.
In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 5) 1941, I hereby order as follows :-

1. This Order may be cited as the Defence (Returns of Stocks of Matches) Order, 1941.
2. Within three days from the date of the publication of this Order every person who has in his possession or under his control any matches in excess of 500 boxes, each box containing approximately 60 match-sticks, shall complete and deliver to me a declaration in the form set forth in the First Schedule hereto in respect of the matches in his possession or under his control.
3. Not later than six days after the last day of each month, commencing from the month of December, 1941, any person who has in his possession or under his control any matches in excess of 500 boxes, each box containing approximately 60 matchsticks, shall complete and deliver to me a return containing the particulars set forth in the Second Schedule hereto in respect of his dealings in matches.
