No. 283. THE DEFENCE REGULATIONS, 1940 TO (No. 5) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 5) 1941, I hereby order as follows:—

- 1. This Order may be cited as the Defence (Returns of Stocks of Matches) Order, 1941.
- 2. Within three days from the date of the publication of this Order every person who has in his possession or under his control any matches in excess of 500 boxes, each box containing approximately 60 match-sticks, shall complete and deliver to me a declaration in the form set forth in the First Schedule hereto in respect of the matches in his possession or under his control.
- 3. Not later than six days after the last day of each month, commencing from the month of December, 1941, any person who has in his possession or under his control any matches in excess of 500 boxes, each box containing approximately 60 matchesticks, shall complete and deliver to me a return containing the particulars set forth in the Second Schedule hereto in respect of his dealings in matches.

- 4. Every person shall permit such person as the Commissioner of the District or I may authorize by writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this order.
 - 5. Any person who-
 - (a) acts in contravention of, or fails to comply with, any of the provisions of this Order; or
 - (b) makes, under any of the provisions of this Order, a declaration or return which is false in any material particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 5) 1941.
