THE PRISON DISCIPLINE LAW, 1879.

REGULATIONS MADE UNDER SECTION 4.

W. D. BATTERSHILL,

Governor.

I, the Governor in Council, in exercise of the powers conferred by section 4 of the Prison Discipline Law, 1879, do hereby make the following regulations:-

1. These regulations may be cited as the Prison (Amendment) Regulations, 1941, and shall be read as one with the Prison Regulations, 1908 to (No. 2) 1939, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Prison Regulations, 1908 to 1941.

2. Paragraph (3) of regulation 147A of the principal Regulations is hereby amended by the deletion therefrom of the words "fifty per cent." and by the substitution therefor of the words "not more than seventy-five per centum"

3. These regulations shall be deemed to have come into operation on the 4th day of January, 1941.

THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 4) 1940, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Weekly Sales of Sugar) (Amendment) Order, 1941, and shall be read as one with the Defence (Control of Weekly Sales of Sugar) Order, 1940, (hereinafter called "the principal Order") and the principal Order and this Order may together be cited as the Defence (Control of Weekly Sales of Sugar) Orders, 1940 and 1941.

2. Clause 3 of the principal Order is hereby amended by the deletion of the words " $50~\rm{drams}$ " and the substitution therefor of the words " $100~\rm{drams}$."
