### THE CUSTOMS LAWS, 1936 TO 1941.

#### ORDER IN COUNCIL No. 2030

MADE UNDER SECTION 59.

#### C. C. WOOLLEY. Governor.

I, the Governor in Council, in exercise of the powers conferred by section 59

No. 2) Order, 1941, and shall be read as one with the Export of Goods Prohibition Gazettes Orders, 1941, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Export of Goods Prohibition No. 3: Orders, 1941 to (No. 2) 1941. 2. Clause 4 of the principal Order is hereby repealed and the following clause 9.10.

substituted therefor :

"4. Notwithstanding anything in this Order contained the following provisions shall apply to the goods and articles hereinafter mentioned :-

- (a) all goods enumerated in the Schedule hereto may be exported without a licence to destinations within the British Empire (with the exception of Hong Kong, Sarawak and the British Pacific Islands), Palestine and Egypt;
- (b) valuables, that is to say, antiques and works of art, articles of gold and platinum, furskins and goods manufactured from furskins, jewellery, postage stamps of any country and watches with cases of precious metal may be exported without a licence to sterling area countries with the exception of Hong Kong, Sarawak and the British Pacific Islands:

Provided that nothing in this paragraph contained shall be deemed to permit the export of diamonds of all kinds, whether or not mounted, set or strung and to articles mounted or set with diamonds without a licence."

#### No. 302. THE DEFENCE REGULATIONS, 1940 TO (No. 5) 1941.

Delegation of Power under Paragraph (5) of Regulation 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 5) 1941, do hereby depute the persons for the time being holding the offices designated in the second column of the Schedule hereto to exercise and perform on my behalf the powers mentioned in the first column of the said Schedule which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 5) 1941.

#### SCHEDULE.

The power to requisition any animal feeding stuffs or any commodities capable of being used for feeding animals, wherever they may be found, and the power connected with such requisitioning conferred by paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 5) 1941. THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR.

Governor. I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following

regulations :-1. These regulations may be cited as the Defence (Amendment No. 6) Regulations, 1941, and shall be read as one with the Defence Regulations, 1940 to (No. 5) 1941. (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence Regulations, 1940 to (No. 6) 1941.

Amendment of regulation 45.

Insertion of new regulations 45A, 45B and 79c.

<sup>2</sup> 2. Regulation 45 of the principal Regulations is hereby amended by the insertion immediately after paragraph (4) of the following paragraph :-

(5) The Governor may, by order, if it appears to him expedient so to do, delegate to any person, subject to such limitations and directions as he may - in such order provide, any of the powers conferred upon him by the preceding - provisions of this regulation."

3. The following regulations shall be inserted in the principal Regulations immediately after regulation 45 :-

45a.—(1) Any person authorized by the Governor to act under this regulation (hereafter in this regulation referred to as 'an authorized person ') may give directions to the owner or master of any vessel which is for the time being at a port in the Colony requiring him-

(a) to take such steps as may be specified in the directions for the purpose of securing that, while the vessel remains at the port, fires occurring in the vessel as the result of hostile attack will be immediately detected and combated;

(b) to secure that, while the vessel remains at the port, either

- at all times or during such periods as may be so specified— (i) in a case where the vessel is equipped with a gun or other instrument or device capable of being used to defend the vessel against hostile attack, that the gun,
  - (ii) in a case where the vessel is a ship propelled by mechanical power, that she is capable of being moved under her own power immediately when ordered to do só;

(c) for the purpose of taking such steps or securing such matters as aforesaid, to secure that such number of persons, or such number of persons of such class or description, as may be so specified, shall be on board the vessel, either at all times while she remains at the port or during such periods while she so remains as may be so specified ;
