THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES) CONSOLIDATION ORDERS, 1940 AND 1941.

NOTICE No. 53 UNDER CLAUSE 13.

The Schedule is hereby amended by the deletion therefrom of Part 21 and the substitution therefor of the following part :—

" PART 21.-CORDWOOD.

In this Part of the Schedule-

the term 'cordwood' means firewood of a size exceeding 3 feet in width or in length, weighed and delivered at the premises of the purchaser within a radius of 2 miles from the office of the Commissioner in each of the towns specified in column 1:

Provided that—

- (a) where cordwood is cut by hand by the supplier at the premises of the purchaser into sizes not exceeding 18 inches in length an additional charge not exceeding 1¹/₂ paras per oke may be made for cutting, and
- not exceeding 1¹/₂ paras per oke may be made for cutting, and
 (b) where cordwood is delivered cut by a machine-driven saw into sizes not exceeding 18 inches in length, an additional charge not exceeding 3 paras per oke may be made for cutting."

No. 305. THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 6) 1941, I hereby order as follows :—

This Order may be cited as the Defence (Bakers Returns) Order, 1941, and shall be read in conjunction with the Defence (Registration of Bakers) Orders, 1940 to (No. 2) 1940, and the words "bakery", "bread" and "registered baker" in this Order shall have the same meaning as in the said Orders.

2. Within 5 days of the publication of this Order in the *Gazette* every registered baker shall complete and deliver to the Commissioner of the District in which his bakery is situated a return showing the number of okes of bread cold or otherwise disposed of by him from his bakery during the period 1st to 30th November, 1941, inclusive.

3. Any person who-

(a) acts in contravention of, or fails to comply with, any of the provisions of this Order, or

(b) makes under any of the provisions of this Order, a return which is false in any material particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 6) 1941.
