### SUBSIDIARY LEGISLATION.

No. 308.

THE PRIZE COURTS ACT, 1894.

PROCLAMATION MADE UNDER SECTION 2 (2).

Whereas under the provisions of section 2 (1) of the Prize Courts Act, 1894, Her late Majesty Queen Victoria was pleased to issue a Commission bearing date the 10th day of July in the sixty-third year of Her Reign :

And whereas under the provisions of section 2 (1) of the said Act the Commissioners for executing the Office of Lord High Admiral of the United Kingdom, etc., and in virtue of the Commission aforesaid issued a Warrant bearing date the 22nd day of April, 1936 :

And whereas under the provisions of section 2 (2) of the said Act the Commission and Warrant aforesaid shall take effect upon a Proclamation by a Vice-Admiral of a British possession made when he is satisfied by information from a Secretary of State that war has broken out between His Majesty and any Foreign State :

And whereas, from information received by me from the Secretary of State, I am satisfied that war has broken out between His Majesty and Finland, Hungary, Roumania and Japan :

Now, therefore, I, Charles Campbell Woolley, Companion of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the Decoration of the Military Cross, Governor and Commander-in-Chief in and over the Colony of Cyprus, Vice-Admiral of the Colony of Cyprus, in exercise of the powers in me as Vice-Admiral of the Colony of Cyprus vested by section 2 (2) of the Prize Courts Act, 1894, do hereby proclaim that war has broken out between His Majesty and Finland, Hungary, Roumania and Japan.

Given under my hand and the Public Seal of the Colony at Nicosia, this 20th day of December, 1941.

A PROCLAMATION.

Whereas by a Proclamation made the 22nd day of September, 1938, and published in Supplement No. 3 to the *Gazette* of the 23rd day of September, 1938, (hereinafter called "the First Proclamation"), it was ordered and proclaimed that on and after the 1st day of January, 1939, the boundary of the Town of Nicosia should be as set forth in Schedule A to the said Proclamation and that the Town of Nicosia comprised within the said boundary should be divided into quarters as set forth in Schedule B to the said Proclamation :

And whereas by a Proclamation dated the 30th day of December, 1938, and published in Supplement No. 3 to the *Gazette* of the 31st day of December, 1938, (hereinafter called "the Second Proclamation"), it was ordered and proclaimed that the First Proclamation should be amended in order to postpone its coming into operation until the 1st day of January, 1940 :

And whereas by a Proclamation dated the 27th day of December, 1939, and published in Supplement No. 3 to the *Gazette* of the 27th day of December, 1939, (hereinafter called "the Third Proclamation"), it was ordered and proclaimed that the First Proclamation should be further amended in order to postpone its coming into operation until the 1st day of January, 1941 :

And whereas by a Proclamation dated the 16th day of December, 1940, and published in Supplement No. 3 to the *Gazette* of the 18th day of December, 1940, (hereinafter called "the Fourth Proclamation"), it was ordered and proclaimed that the First Proclamation should be further amended in order to postpone its coming into operation until the 1st day of January, 1942 :

And whereas it has been made to appear to me desirable that the coming into operation of the First Proclamation should be further postponed for one year :

Now, therefore, in exercise of the powers vested in me by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, do hereby order and proclaim that the First Proclamation as amended by the Second, Third and Fourth Proclamations shall be further amended by the deletion of the words "1st day of January, 1942," appearing therein and by the substitution therefor of the words "1st day of January, 1943,".

**No. 310. THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1941.**

ORDER MADE UNDER REGULATION 2.

I, the Governor, in exercise of the powers conferred by regulation 2 of the Defence Regulations, 1940 to (No. 6) 1941, do hereby order as follows:—

1. This Order may be cited as the Defence (Essential Services) (No. 2) Order, 1941, and shall come into operation on and from the date of its publication in the *Gazette*.

2. The following services are declared to be of public utility or to be essential for the prosecution of the war or essential to the life of the community, that is to say:—

Defence works.

**No. 311. THE CUSTOMS LAWS, 1936 TO 1941.**

ORDER IN COUNCIL No. 2031

MADE UNDER SECTION 65.

I, the Governor in Council, in exercise of the powers conferred by section 65 of the Customs Laws, 1936 to 1941, do hereby order as follows:—

1. This Order may be cited as the Wharfage Dues (Export of Grape Must) Order, 1941.

2. From and after the 1st day of December, 1941, there shall be levied and collected upon the export from the Colony of grape must, wharfage dues at the special rate of one-half piastre for each tin or other receptacle containing such grape must, not exceeding 50 okes in weight.
