THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

## ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Orounda, in the District of Nicosia, on the 13th day of April, 1941, it was determined by the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Orounda :

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Orounda has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Orounda. Now, therefore, His Excellency the Governor, in exercise of the powers vested

in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :-

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Orounda, in the District of Nicosia.
