THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1941. No. 320.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 6) 1941, I hereby order as follows :-

1. This Order may be cited as the Defence (Controlled Goods) Amendment Order, 1941, and shall be read as one with the Defence (Controlled Goods) Order, 1941, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence Controlled Goods Orders, 1941. 2. Clause 4 of the principal Order is hereby amended as follows :-

(a) by the deletion therefrom of paragraph (2) and the substitution therefor of the following paragraph :-

"(2) Every special permit issued under the provisions of paragraph (1) hereof may contain such terms and conditions (including the price at which such controlled goods are to be sold or purchased by wholesale or by retail) as may be specified therein and no person, whether such person is the holder of the permit or not, shall sell or otherwise dispose of any controlled goods to which the permit relates except in accordance with the terms and conditions and the price specified therein.";

(b) by the addition thereto of the following paragraph :-

(3) With a view to bringing the prices contained in any special permit to the notice of the public and of persons who are not the holders of such permit, a notice shall be published under my hand in one or more newspapers circulating in Cyprus.'

3. The principal Order is hereby amended by the insertion immediately after clause 4 of the following clause :-

" 4A. Not later than six days after the last day of each month commencing from the month of December, 1941, every person who has in his possession or under his control any controlled goods in excess of the quantity described in the second column of the First Schedule hereto shall complete and deliver to me a return of the goods in his possession or under his control, in the form set forth in the Third Schedule hereto.

4. Paragraph (b) of clause 6 of the principal Order is hereby amended by the insertion immediately after the words "clause 3" of the words " or clause 4a".

5. The principal Order is hereby amended by the insertion therein immediately after the Second Schedule of the following Schedule :-
