**THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1941.**

**BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF LARNACA.**

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1941, and otherwise, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws:—

1. These bye-laws may be cited as the Municipal Corporation (Larnaca) Amendment Bye-laws, 1941, and shall be read as one with the Municipal Corporation (Larnaca) Bye-laws, 1931 to 1936, (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Larnaca) Bye-laws, 1931 to 1941.

2. Lines 1 to 7 of bye-law 28A (1) of the principal Bye-laws shall be replaced by the following:—

"The shops, sheds or stands, situated in the municipal market and numbered 1 to 19 inclusive, and 46 to 65 inclusive, are hereby provided and shall henceforth be used as a public market of perishable goods."

The above bye-laws have been approved by His Excellency the Governor.

**THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES) CONSOLIDATION ORDERS, 1940 AND 1941.**

A.—The Schedule is hereby amended by the deletion therefrom of Part 22 and the substitution therefor of the following part:—

**"PART 22.—FUEL OIL.**

*Limitation*: No retailer shall be obliged to sell kerosene in a new sealed tin (with tin) in the following places: Nicosia, Famagusta, Larnaca, Limassol, Paphos, Kyrenia, Polis, Xeros, Lefkoniko, Peristerona (Nicosia District), Morphou and Lefkara."
