ORDER MADE BY THE GOVERNOR UNDER REGULATION 3.

I, the Governor, in exercise of the powers conferred by regulation 3 of the Emergency Powers (Cyprus Defence) (Finance) Regulations, 1940 to (No. 1) 1940, do hereby order as follows:—

1. This Order may be cited as the Defence (Restrictions on Dealings with Securities) (Amendment) Order, 1941, and shall be read as one with the Defence (Restrictions on Dealings with Securities) Order, 1940, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Restrictions on Dealings with Securities) Orders, 1940 and 1941.

2. Clause 4 of the principal Order is hereby amended by the deletion from the list of securities enumerated therein, securities in respect of which the principal, interest or dividends were payable in Belgian Congo currency.
