

No. 48. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1941.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1941, I hereby order as follows:—

1. This Order may be cited as the Defence (Sale of Italian Sulphur Restriction) Order, 1941.

2. For the purposes of this Order "dealer in Italian sulphur" means any person who has in his possession or under his control—

(a) any Italian sulphur for the purposes of sale by retail or by wholesale, and
(b) any Italian sulphur exceeding one bag of 50 kilograms.

"Italian sulphur" means sulphur of Italian origin imported into Cyprus.

3. Within five days of the publication of this Order in the *Gazette* every dealer in Italian sulphur shall complete and deliver to me, at Nicosia, a declaration in the form set out in the Schedule hereto, in respect of all Italian sulphur which he holds stock or in his possession or under his control.

4. On and from the date of the publication of this Order in the *Gazette* no dealer in Italian sulphur shall sell any Italian sulphur to any person except under and in virtue of a special permit—

(a) issued under my hand; and

(b) delivered either to the dealer in Italian sulphur or to the prospective purchaser of the Italian sulphur.

5. Every special permit issued under the provisions of clause 4 of this Order may contain such terms and conditions (including the price at which the Italian sulphur is to be sold or purchased) as may be specified therein.

6. Any dealer in Italian sulphur who—

(a) acts in contravention of the provisions of this Order or of any of the terms and conditions specified in a special permit issued under this Order; or

(b) makes a false declaration under clause 3 of this Order,

shall be liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1941.

NOTICE No. 23 UNDER CLAUSE 13.

The Schedule is hereby amended by the deletion therefrom of Part 5 and the substitution therefor of the following part:—

"PART 5.—CONDENSED MILK.

(1) Type.	(2) Retail Price.	(3) Wholesale Price.
1. "Gold Bird" Brand ..	11 piastres per tin.	14 shillings per 12 tins.
2. Other Brands	8 piastres per tin.	10 shillings per 12 tins.

In this Part of the Schedule—

the term 'wholesale' means sale or purchase of condensed milk in quantities of not less than 12 tins at any one time or at any single transaction."
